#### REPORT OF THE ITTO FELLOWSHIP SELECTION PANEL

(Item 18 of the Provisional Agenda)

1. Fellowship selection for 2016 was conducted electronically. However, the Panel met once during the Fifty-second Session of the ITTC to finalize the selection of successful applicants for the Autumn 2016 Cycle. The Selection Panel was composed of:

Due to the impairment of ITTO funds, no awards have been made under the spring cycle 2016 and the shortlisted applications of the spring cycle were considered during the selection panel meeting at ITTC 52<sup>nd</sup> in Yokohama, Japan. The Selection Panel considered a total of 53 applications made up of 19 applications from Africa, 9 from Asia/Pacific, 23 from Latin America and Caribbean region and 2 from consumer countries. 15% of the applications were in the field of Economic Information and Market Intelligence (EIMI); 4% in the field of Forest Industry (FI) and 81% in the field of Reforestation and Forest Management (RFM). 43% of the applications were submitted by female applicants.

While reviewing these 53 applications, the Panel used the following selection criteria:

- (i) Consistency of the proposed activities with the ITTO fellowship programme's objective and priority areas:
- (ii) Qualifications of the applicants to undertake the proposed fellowship activities;
- (iii) Applications and benefits of the skills and knowledge to be acquired or advanced under the fellowship activities; and
- (iv) Reasonableness of costs in relation to the proposed activities.

The Panel took into account the balance among the three subject areas and regions as well as the opportunity to promote the participation of women. The Panel also took into account the Strategic Action Plan in its selection Process. The Panel recommends to the Council to award 11 fellowships, subject to the availability of funds at a total cost of US\$58,724.71. Women account for 45% of the recommended applicants. 55% of the recommended applicants are from Africa, 9% from Asia/Pacific, 36% from Latin America and Caribbean region for a project in Latin America. The recommended applicants are listed in the Appendix to this report.

- 3. The delegate of the USA Mr. Luke D. Thompson mentioned that the Fellowship Programme is one of the top priorities for his government, as it provides training in tropical forestry for future generations and, his governments expects that the programme will come back to its regular cycle and thanked all panel members for their work in appraising the applications.
- 4. The chair of ITTO Fellowship Selection Panel Mr. Agyarko Tabi appreciated the great work of all panel members and donors for their great support to the fellowship programme and thanked particularly USA's generous contribution in the amount of US\$60,000.
