

This will be achieved through enhanced cooperation in climate change adaptation and mitigation, sustainable forest management and livelihood improvement programs. Under the broader scope of climate change impacts, AFoCO will promote and undertake action-oriented forest cooperation programs and projects to achieve its mission. For sustainable forest management, AFoCO works to rehabilitate degraded forest land and address deforestation and forest degradation. It also explores common interests and positions among the member states as a unique intergovernmental organization in the forest sector

The Secretariat's operating budget is composed of mandatory contributions from the Parties to AFoCO and funds from other sources, including voluntary contributons. The Secretariat's Special Acount for cooperative activities include fund dedicated to programs and projects such as the Landmark Program, regional projects, and country projects. The bulk of cash contributions are from the Republic of Korea, who is also a Party to AFoCO.

Efforts have been made to diversify funding sources by reaching out to multilateral and bilateral funds such as the ASEAN Korea Cooperation Fund (AKCF), Mekong-Republic

of Korea Cooperation Fund (MKCF), and Korea International Cooperation Agency (KOICA). Private funding from L'occitane, Rabobank, SK Forest, and Woori Bank, have also been secured.

3. Short History:

Created in 1948, IUCN is now the world's largest and most diverse environmental network, harnessing the knowledge, resources and reach of our more than 1,400 Member organisations and 15,000 experts. This diversity and expertise makes IUCN the global authority on the status of the natural world and the measures needed to safeguard it.

IUCN was fundamental to the creation of key international conventions including the Ramsar Convention on Wetlands (1971), the World Heritage Convention (1972), the Convention on International Trade in Endangered Species (1974), and the Convention on Biological Diversity (1992). In 1980, IUCN, the UN Environment Programme (UNEP) and the World Wildlife Fund (WWF) published the World Conservation Strategy which helped define the concept of 'sustainable development' and so shaped the global agenda. A subsequent version of the strategy, Caring for the Earth, was published by the three organisations in the run-up to the 1992 Earth Summit. It served as the basis for international environmental policy and guided the creation of the Rio Conventions on biodiversity (CBD), climate change (UNFCCC) and desertification (UNCCD).

In 1999, as environmental issues continued to gain importance on the international stage, the UN General Assembly granted IUCN official observer status.

IUCN is a membership Union uniquely composed of both government and civil society organisations. IUCN is the only institution that brings governments and civil society together with one purpose: to advance sustainable development and create a just world that values and conserves nature. The Union's diversity, depth and reach give its decisions a powerful mandate and its actions profound impact. It provides public, private and non-governmental organisations with the knowledge and tools that enable human progress, economic development and nature conservation to take place together.

IUCN is a leading provider of conservation data, assessments and analysis. Its broad membership enables IUCN to fill the role of incubator and trusted repository of best practices, tools and international standards. IUCN provides a neutral space in which diverse stakeholders including governments, NGOs, scientists, businesses, local communities, indigenous peoples' organisations and others can work together to forge and implement solutions to environmental challenges and achieve sustainable development.

Working with many partners and supporters, IUCN implements a large and diverse portfolio of conservation projects worldwide. Combining the latest science with the traditional knowledge of local communities, these projects work to reverse habitat loss, restore ecosystems and improve people's well-being. Through its status as a Project Agency for the Global Environment Facility (GEF) and an Accredited Entity for the Global Climate Fund (GCF), IUCN has been entrusted to mobilise significant sources of multilateral funding and to use its global network of Members and experts to put this funding to greatest effect.

- 3. Short History: The Regional Community Forestry Training Centre for Asia and the Pacific (RECOFTC) was founded in Thailand in 1987. RECOFTC's mission is to assist the people of the Asia Pacific Region to manage their forests and related natural resources for the greatest social benefit with due consideration for cross-cultural perspectives, promotion of synthesis of local wisdom and customs with modern knowledge and institutions and to foster deeper understanding of their rights and responsibilities over forests.
- 4. <u>Constitution</u> [Please provide charter or other establishing document in all available languages]: RECOFTC Charter is signed by the governments of Cambodia, People's Republic of China, Lao People's Democratic Republic, Union of Myanmar, Switzerland and Socialist Republic of Vietnam. As per its Charter, RECOFC shall operate as a non-profit, autonomous organization, international in status and non-political in management, staffing and operations. RECOFTC shall have a Board of Trustees and an Executive Committee tat includes the Executive Director. The details of the organization and management shall be decided by the Board.
- 5. Aims, Objectives, Activities [Please describe the general aims and objectives of the Organization and the activities undertaken]: RECOFTC strives for a future where people live equitably and sustainably in and beside healthy, resilient forests. It is the only non-profit organization of its kind in Asia and the Pacific. With nearly 36 years of working experience with people and forests, RECOFTC has built trusting relationships with partners at all levels. RECOFTC influence and partnerships extend from multilateral institutions to governments, private sector and local communities. RECOFTC innovations, knowledge and initiatives enable countries to foster good forest governance, mitigate and adapt to climate change, and achieve the Sustainable Development Goals of the United Nations 2030 Agenda.
 - RECOFTC takes a long-term, landscape-based and inclusive approach to supporting local communities to secure their land and resource rights, stop deforestation, find alternative livelihoods and foster gender equity. RECOFTC's entry point to sustainable development and climate change solutions is community forestry. It works throughout the Asia-Pacific region, with a main office in Bangkok and offices in seven countries: Cambodia, Indonesia, Lao PDR, Myanmar, Nepal, Thailand and Viet Nam.
- 6. <u>Structure</u>: RECOFTC governance is overseen by a Board of Trustees, whereas a day a day to operation and organizational management is run by an Executive Committee, consisting of unit directors and headed by the Executive Director. RECOFTC main office is located in Bangkok in the Kasetsart University campus, and it has seven country offices located in Cambodia, Indonesia, Lao PDR, Myanmar, Nepal, Thailand and Viet Nam. The main office provides technical, operational, financial and communication support to country offices, through its key units, including Executive Office, Program Coordination and Technical Services unit, Knowledge Management, Information Technology and Strategic Communications Unit, and Corporate Service unit. Each country office is headed by a country director and the team members are the national staff in each country.
- 7. Finance [Please indicate source of revenue]: RECOFTC program plan is supported by two core donors the Swiss Agency for Development and Cooperation (SDC) and the Swedish International Development Cooperation Agency (Sida), and a number of project donors. The unrestricted support from two core donors provides significant operating resources that allow for flexibility in

overall operations and growth and leveraging to implement innovative work that helps generate more resources for RECOFTC. Beside core donor funds, RECOFTC generates funds through solicited and unsolicited projects from a range of donors, including EU, USAID, USFS, UNDP, UNEP, FAO, BMU Germany etc.

- 8. <u>Publications</u>: RECOFTC produces a number of publications on various topics such as climate change mitigation and adaptation, forest governance, forest-based enterprise development, gender mainstreaming and social inclusion, social safeguards and rights and tenure security for the Indigenous people and local communities, forest fire management etc. RECOFTC publications are available on its website (https://www.recoftc.org/publications) and can be accessed freely.
