Developments in the Netherlands

- Facilitates development of Certification System
 - Universally applicable certification system
 - Reference for recognition of other systems

- Procurement policy: use of legal timber
 - Process of defining legality
 - Linking legality to SFM

Developments in the Netherlands Parliament

- Parliament drafts proposal for Legislation
 - Originally to distinguish identified "good" wood from other wood
 - Since 1998, still in discussion!
 - Presently focus on:
 - Dutch universally applicable certification system
 - Establishment of an Agency to control the system
 - Issuing certificates and assessing certificates of other systems (similar to KEURHOUT)

- The more legislation.....
- The more chance of illegality.....and the less effective is the requirement of full legal compliance as an instrument to resolve a specific problem

Protocol for the Validation of legality of Timber

Defining legality is dependent on purpose and needs to be viewed from:

Original concern about illegal logging

- Depletion of forest, loss of biodiversity
- Degrading environments of indigenous people
- Frustrating process towards SFM
- Loss of income of local populations and governments
- Disturbing markets

and in view of:

- Societal developments:
 - Governance and legislation reform
 - Promoting SFM (certification)
 - Call for direct action to curb illegal logging and its consequences

Protocol for the Validation of Legality of Timber Content

- Protocol = procedure to investigate and endorse a claim of the legality of timber
- Protocol confirms the Legal Origin
- Protocol comprises:
 - Validation procedure
 - Standards (C&I) for Legal Origin and CoC
- Standards contain requirements for:
 - Quality of auditors
 - Assessment scheme applied by the auditor
 - Standard (C&I) used by the auditor

Protocol for the Validation of legality of Timber Relation with SFM

- Establishing legal origin fits in three step approach towards SFM
- 1) Timber from legal origin (timber is not stolen)
- 2) Transition timber; from forest managed according to a program to achieve SFM including full legal compliance
- 3) Certified timber; from SFM certified forests which implies full legal compliance.

Protocol for the Validation of legality of Timber Relevant Legislation

- The protocol for Legal Origin is based on the concept of:
- Legislation, rules en prescriptions in the country of origin (where the trees have been harvested)
- International Treaties and Conventions which have been ratified or which according to international law should be respected

Protocol for the Validation of legality of Timber C & I for Legal Origin

- Legal registration of logging company
- Lawful permit for logging specified forest
- Exclusive harvest of identified and formally approved trees
- Royalties and timber fees paid
- Monitoring harvest and corrective actions
- Customary cutting rights accepted

RIL VER FIED

Reduced Impact Logging in a modular system

- Tropical Forest Foundation, TFF, (US) launched concept of "RIL Verified" in 2003.
- August 2003, first shipment "RIL Verified" Meranti from Indonesia arrives at Norfolk
- RV = harvested using RIL and legal

Reduced Impact Logging in a modular system

- TFF is considering to develop RIL standard (C & I)
- Standard might comprise:
 - RIL technology elements (moduls for mapping road design, felling, skidding, safety etc.)
 - Outcome requirements (status of residual stand)
 - Components of the management system (plan, act, check, improve)
 - Training and education level

Reduced Impact Logging in a modular system

- RIL standard may fit in modular system towards SFM
- "RIL Verified" could well fit in phased approach

- Communication must prevent confusion and wrong interpretation in the market
- Communication must be effective as to providing market access.
