#### **Forestry Support Programme**





# Phase 1: Project Scope Identification




#### **Project Identification**

- Define the scope of the project (Voluntary/Kyoto);
- Identify potential project proponents;
- Initial Site Identification and Feasibility Evaluation.



# Phase 1: Project Scope Identification



#### **Project Viability**

- Review of the procedures, management plans and associated documents;
- Objectively quantify the project's potential to reach verification and issuance of Carbon Credits;
- Findings are filed in a Inception Report.



# Phase 2: Project Due Diligence



#### **Mitigating Project Risk**

- Financial Risk;
- Environmental Risk;
- Legal Risk;



### Phase 2: Project Due Diligence




#### **Due Diligence**

- Due diligence on risk analysis to mitigate identified risks
- Projected carbon gain
- Anticipated leakages
- Agreement negotiation and facilitation between investors and producers.



# **Phase 3: Project Development**



- Drafting Comprehensive Action Plan;
- Drafting Forest Management Plan;
- Drafting Carbon Development Plan;
- Methodology development and submission;
- Carbon Project Documentation preparation and submission;
- Project registration for 3rd party verification.
- Full certification for FSC & Carbon



# **Project Monitoring**




- GFS ensures that projects are established correctly and in a timely fashion;

- GFS strives to support all project aspects to the required level of transparency.




### **Forest Certification**
