INTERNATIONAL TROPICAL TIMBER COUNCIL First session Geneva, 17 June 1985

REPORT OF THE INTERNATIONAL TROPICAL TIMBER COUNCIL ON ITS FIRST SESSION

Held in Geneva from 17 to 28 June 1985 (first part), from 25 to 29 November 1986 (second part) and from 28 July to 1 August 1986 (third part)

A. Introduction

- 1. In conformity with article 37, paragraph 5, of the International Tropical Timber Agreement, 1983, the Secretary-General of the United Nations convened the first session of the International Tropical Timber Council. The session was held at the Palais des Nations in Geneva in three parts, the first from 17 to 28 June 1985, the second from 25 to 29 November 1985 and the third from 28 July to 1 August 1986. The members of the Council and a number of observers for States not members of the United Nations, for specialized and related agencies, for intergovernmental and non-governmental organizations 1/took part in the first session. The Council held 33 meetings in the course of its session, 18 of them during the first part, 10 during the second part and 5 during the third part.
- B. Opening of the session (agenda item 1)
- 2. The session was opened on 17 June 1985 by Mr. M.A. Ashiabor, Director of the Commodities Division of UNCTAD, who made a statement on behalf of the Deputy Secretary-General in charge of UNCTAD. Mr. J.E.M. Arnold, Chief, Policy and Planning Service of the Forestry Department of FAO, addressed the Council on behalf of the Director-General of FAO.
- Report on membership of the Council and on definitive signature, ratification, acceptance or approval, and notification of provisional application of the International Tropical Agreement, 1983 (agenda item 2)
- 3. At the opening of the first part of the session, the Council comprised 32 member States and one intergovernmental organization, namely, Brazil, Cameroon, Congo, Côte d'Ivoire, Ecuador, Egypt, European Economic Community (Belgium/Luxembourg, Denmark, France, Germany, Federal Republic of, Greece, Ireland, Italy, Netherlands, United Kingdom of Great Britain and Northern Ireland), Finland, Gabon, Ghana, Honduras, Indonesia, Japan, Liberia, Malaysia, Norway, Peru, Philippines, Spain, Sweden, Switzerland, Union of Soviet Socialist Republics and the United States of America. During the first part of the session, the Council welcomed two new members, namely,

Bolivia and the Republic of Korea. During the second part of the session, the Council admitted two other members, namely, Papua New Guinea and Thailand. In the course of the third part of the session, the Council recorded the presence of five new members, namely, Austria, Canada, China, India and Trinidad and Tobago, thus bringing the number of its members to 42. (See the list of the members of the Council in annex III).

D. Distribution of votes (agenda item 3)

- 4. At its 5th meeting, on 19 June 1985, the Council approved the initial distribution of votes. 2/ At its 11th meeting, on 26 June 1985, it approved the distribution of votes resulting from the inclusion of two new members. 3/ At its 25th meeting, on 28 November 1985, it approved the distribution of votes resulting from the inclusion of two new members. 4/ At its 30th meeting, on 28 July 1986, it approved the distribution of votes resulting from the inclusion of five new members (see annex IV).
- E. Election of the Chairman and the Vice-Chairman of the Council (agenda item 4)
- 5. At its 3rd meeting, on 18 June 1985, the Council elected Mr. Hans-Olle Olsson (Sweden) Chairman. At its 4th meeting, on the same day, it elected Mr. Poedji Koentarso (Indonesia) Vice-Chairman. Mr. Koentarso presided at the 17th meeting on 28 June 1985, and the 32nd and 33rd meetings held on 1 August 1986. At its 33rd meeting, the Council elected Mr. Denis Konan (Côte d'Ivoire) Chairman for 1987.
- F. Presentation of the report of the Preparatory Committee (agenda item 5)
- 6. The Preparatory Committee held a single meeting from 2 to 6 July 1984 in Geneva. Its Chairman was Mr. Laschinger (Canada). In the absence of the Chairman, Mr. B. Ekaba-Itoura (Congo), Vice-Chairman, presented the report of the Preparatory Committee 5/ to the Council which took note of it at its 3rd meeting of 18 June 1985.
- G. Adoption of the agenda and organization of work (agenda item 6)
- 7. At its 5th meeting, on 19 June 1985, the Council adopted the agenda for its first session (see annex II).
- H. Admission of observers (agenda item 7)
- 8. The following States and organizations were admitted by the Council as observers at its first session:

I. Credentials of representatives (agenda item 8)

9. At its 9th meeting, on 24 June 1985, in conformity with article 3 of its rules of procedure, the Council established a Credentials Committee composed of the representatives of Cameroon, France, Ghana, Japan, Peru, Philippines, Union of Soviet Socialist Republics and the United States of America. At its 1st meeting, on 25 June 1985, the Committee elected Mr. S. Makon Wehiong (Cameroon) Chairman and at its 2nd meeting, on 27 June 1985, it elected Miss L. Auer (France) Vice-Chairman. The Committee held two further meetings on 29 November 1985 and 31 July 1986. At each of its meetings, the Committee found the credentials it was required to examine to be in good and due form and recommended to the Council that they be approved. The Council accordingly approved them.

J. Adoption of the rules of procedure of the Council (agenda item 9)

10. At its 17th meeting, on 28 June 1985, the Council adopted its rules of procedure, 14/ with the exception of article 32 (see Decision 1 (I) in annex I). This article, which is concerned with the question of the languages of the International Tropical Timber Organization, would require a decision by the Council at its second session.

- K. Location of the headquarters of the Organization (agenda item 10)
- 11. At the 5th meeting of the Council, on 19 June 1985, the representatives of Belgium, Brazil, France, Greece, Indonesia, Japan, the Netherlands and the United Kingdom confirmed the respective offers of Brussels, Rio de Janeiro, Paris, Athens, Djakarta, Yokohama, Amsterdam and London as sites for the headquarters of the Organization.
- 12. At its 10th meeting, on 26 June 1985, the Council decided by consensus that a vote would be taken by secret ballot on the question of the headquarters of the Organization.
- 13. After the candidatures of Athens, Brussels and London had been withdrawn, on 26 June the Council took an initial and inconclusive vote. After that vote, France withdrew the candidature of Paris. Four additional ballots were held on 26 and 27 June on the remaining candidatures of Amsterdam, Djakarta, Rio de Janeiro and Yokohama, without any decision being taken.
- 14. In the second part of the session, after two further and inconclusive ballots on 25 November 1985, Brazil withdrew the candidature of Rio de Janeiro. Six additional ballots between 26 and 30 November failed to decide among the three remaining candidatures.
- 15. When the third part of the session (30th meeting) opened, on 28 July 1986, the Netherlands informed the Council of the withdrawal of the candidature of Amsterdam. At the 31st meeting on 29 July, after a final ballot, the town of Yokohama was designated as the location of the headquarters of the International Tropical Timber Organization. 15/ (Decision 3 (I) appears in annex I).
- L. Appointment of the Executive Director (agenda item 11)
- 16. At its 6th meeting, on 20 June 1985, the candidatures of Mr. Freezailah bin Che Yeom (Malaysia) and Mr. G. Anguilé (Gabon) were submitted to the Council. At its 10th meeting, on 26 June 1985, having taken note that article 16, paragraph 1, specifies that the Executive Director shall be appointed by special vote, the Council decided to have a secret ballot. However, no vote was taken during the first part of the session.
- 17. During the second part of the session, there were six ballots between 28 and 30 November 1985, but without result.
- 18. In the interval between the second and third parts of the session, France submitted the candidate of Mr. J. Clément for the post of Executive Director of the Organization.
- 19. At its 31st meeting, on 20 July 1986, the Council held two ballots in respect of the three candidates. In the second ballot, it appointed Mr. Freezailah bin Che Yeom (Malaysia) Executive Director of the International Tropical Timber Organization. 16/ (Decision 2 (I) appears in annex I). The Executive Director will have the level of Assistant Secretary-General (see Decision 4 (I) in annex I).

- M. Establishment of conditions of accession to the Agreement (agenda item 12)
- 20. At its 9th meeting, on 24 June 1985, the Council established the conditions of accession to the Agreement and made provision for the question to be reviewed at its second session. (Decision 2 (I) appears in annex I).
- N. Establishment of the secretariat (agenda item 13 (a))
- 21. In its Decision 7 (I) taken at its 33rd meeting, on 28 July 1986, the Council authorized the Executive Director, as an interim arrangement, to engage two consultants for a period of four man-months and four executive and/or professional staff members. (The text of the decision appears in annex I of the report).
- O. Preparation of the financial rules of the Organization (agenda item 13 (b))
- 22. Lack of time prevented the Council from considering this question, which was deferred until its second session. In that connection, it has before it document ITTC(I)/3.
- P. Preparation of the staff regulations and rules of the Organization (agenda item 13 (c))
- 23. The Council also postponed this question until its second session. Documents ITTC(I)/4 and ITTC/PC/R.4 are available to it.
- Q. Preparation of a Headquarter's agreement (agenda item 13 (d))
- 24. At its 32nd meeting, on 1 August 1986, the Council established a "Host Country Committee" entrusted with drawing up a draft Headquarters Agreement. The Committee is composed of the representatives of Brazil, Ghana and the Philippines for the producers and the Soviet Union, the United Kingdom and the United States of America for the consumers.
- R. Approval of the administrative budget and determination of the date on which contributions to the administrative budget become due (agenda item 14)
- 25. In its resolution I of 18 November 1983, the United Nations Conference on Tropical Timber had requested the United Nations General Assembly to provide the advances required for the meetings of the Preparatory Committee and for the first session of the Council, refundable as soon as possible by the International Tropical Timber Organization. The sum of \$US 200,000 was advanced by the United Nations.
- 26. When it had become obvious that the Council would be unable to complete its work at the conclusion of the second part of its session and, in particular, that the lack of decisions on agenda items 9, 10, 11 and 13 (a) precluded the formal approval of an administrative budget, the Council, at its 28th meeting, on 29 November 1985, approved an initial contribution of \$250,000 to the 1986 budget. (The text of Decision 6 (I) appears in annex I. See also document ITTC(I)/10).

- 27. At its 33rd meeting, on 1 August 1986, the Council approved the Organization's administrative budget for the remaining two months of 1986 and the first half of 1987. The budget is predicated on a total amount of \$1,139,000, less the portion of the operating costs to be assumed by the host country. The dates on which contributions would become due were set at 1 October 1986 and 1 January 1987 respectively. 17/ (Decision 7 (I) appears in annex I).
- S. Date and place of the first session of the Council Committees (agenda item 15)
- 28. This item was postponed until the Council's next session.
- T. Provisional agenda, date and place of the second session of the Council (agenda item 16)
- 29. The provisional agenda for the second session of the Council will be prepared by the Executive Director. The session will be held at Yokohama in the second half of March 1987.
- U. Other business (agenda item 17)
- 30. No specific issue was raised under this agenda item.
- V. Record of decisions (agenda item 18)
- 31. The texts of the main decisions taken by the Council at its first session appear in annex \mathbf{I}_{\bullet}

Annex I

TEXTS OF THE MAIN DECISIONS ADOPTED BY THE COUNCIL AT ITS FIRST SESSION

Decision 1 (I). Rules of procedure of the Council

The International Tropical Timber Council,

Adopts its rules of procedure as they appear in document ITTC (I)/14, with the exception of article 32.

17th meeting 28 June 1985

Decision 2 (I). Establishment of conditions of accession to the Agreement

The International Tropical Timber Council,

Noting that the International Tropical Timber Agreement, 1983, is open for accession by the Governments of all States upon conditions established by the Council in accordance with article 35 of the Agreement,

- l. <u>Decides</u> that for all States acceding to the International Tropical Timber Agreement, 1983, the condition shall be that they accept all the obligations of the Agreement,
- 2. Decides also that the time-limit for the deposit of instruments of accession shall be the date of the opening of the second session of the Council;
 - 3. Decides further to review this subject at its second session.

9th meeting 24 June 1985

Decision 3 (I). Headquarters of the Organization

The International Tropical Timber Council,

Decides, in conformity with article 3, paragraphs 3 and 4, of the International Tropical Timber Agreement, 1983, that the International Tropical Timber Organization shall have its headquarters at Yokohama, Japan.

31st meeting 29 July 1986

Decision 4 (I). Appointment of the Executive Director

The International Tropical Timber Council,

Decides, in conformity with article 16, paragraphs 1 and 2, of the International Tropical Timber Agreement, 1983, to appoint

Mr. Freezailah bin Che Yeom as the Executive Director of the International Tropical Timber Organization on 1 November 1986 for a period of three years and five months.

31st meeting 29 July 1986

Decision 5 (I). Level of the Executive Director

The International Tropical Timber Council,

- 1. Reaffirms the importance of the International Tropical Timber Organization as recognized in the Preamble of the Agreement and the importance of its future role;
- 2. Recognizes that, in most international commodity organizations, the Executive Directors are appointed at the level of Under Secretary-General, but in view of the financial constraints of the Organization decides to appoint the Executive Director of the International Tropical Timber Organization at the level of Assistant Secretary-General,
- 3. Recalls that the success of the International Tropical Timber Agreement will greatly depend on voluntary contributions and reaffirms its willingness to ensure that the work of the Organization is conducted in the most efficient manner.

33rd meeting 1 August 1986

Decision 6 (I). Initial contribution to the administrative budget for 1986

The International Tropical Timber Council,

Noting that additional time is required for completion of the work of its first session,

Taking note of the note by the Chairman of the Council on initial contributions to the administrative budget (contained in document ITTC(I)/10),

- 1. Decides to adjourn its resumed first session,
- 2. Approves an initial contribution to the administrative budget for 1986 in an amount of \$US 250,000;
- 3. <u>Invites</u> members, if they so wish, to make further contributions to the administrative budget to cover the initial operating costs of the ITTO secretariat,
- 4. Requests the Secretary-General of UNCTAD to open an account on behalf of the ITTO and to administer that account in consultation with the Chairman of the Council, until such time as an Executive Director is appointed,

5. Further requests the Secretary-General of UNCTAD, in consultation with the Chairman of the Council, to make the necessary arrangements for a further resumption of the first session of the Council, for a period of one week, during the first half of 1986.

28th meeting 29 November 1985

Decision 7 (I). Interim budget for the remainder of 1986 and the first half of 1987

The International Tropical Timber Council,

Expressing satisfaction that Yokohama has been elected as the site of the Headquarters of the International Tropical Timber Organization and that Mr. Freezailah bin Che Yeom has been appointed as its Executive Director,

Appreciating the preparedness of Mr. Freezailah bin Che Yeom to assume his functions as of 1 November 1986,

- Authorizes the Executive Director, as an interim arrangement;
- (a) To engage two consultants, for a period of four man-months starting 1 November 1986, to assist the Executive Director in formulating a draft work programme and draft budget;
- (b) To recruit four executive and/or professional staff members to assist the Executive Director in his work, starting 1 January 1987;
- 2. Adopts the interim budget for the remainder of 1986 and the first half of 1987 as annexed hereto;
- 3. Decides that the second session of the Council shall be held in the second half of March 1987, at Yokohama;
- 4. Requests the Executive Director to present the draft work programme of the Organization, including inter alia the structure of the Organization and staff functions, and the draft budget for the remaining part of the financial year to the second session of the Council for its consideration and approval, and to make these drafts available to member Governments at least one month before the date of the second session;
- 5. Decides that the contributions to the administrative budget for the remainder of 1986 shall become due on 1 October 1986,
- 6. Appeals to member Governments to make their contributions to the administrative budget for the first half of 1987 not later than the due date of 1 January 1987, and preferably together with those for the remainder of 1986.
- 7. <u>Further appeals</u> to those member Governments which have not yet paid their assessed contributions to the initial administrative budget for 1986 adopted on 29 November 1985 to do so without any further delay.
