## REPORT OF THE ITTO FELLOWSHIP SELECTION PANEL

(Item 15 of the Provisional Agenda)

1. Fellowship selection for 2013 was conducted electronically. However, the Panel met once during the Forty-ninth Session of the ITTC to finalize the selection of successful applicants for the Autumn 2013 Cycle. The Selection Panel was composed of:

2. The Selection Panel considered a total of 73 applications made up of 38 applications from Africa, 13 from Asia/Pacific and 22 from Latin America and Caribbean region. Eight percent of the applications were in the field of Economic Information and Market Intelligence (EIMI); 12% in the field of Forest Industry (FI) and 80% in the field of Reforestation and Forest Management (RFM). Twenty five percent of the applications were submitted by female applicants.

While reviewing these 73 applications, the Panel used the following selection criteria:

- (i) Consistency of the proposed activities with the ITTO fellowship programme's objective and priority areas;
- (ii) Qualifications of the applicants to undertake the proposed fellowship activities;
- (iii) Applications and benefits of the skills and knowledge to be acquired or advanced under the fellowship activities; and
- (iv) Reasonableness of costs in relation to the proposed activities.

The Panel took into account the balance among the three subject areas and regions as well as the opportunity to promote the participation of women. The Panel also took into account the Strategic Action Plan in its selection Process. The Panel recommends to the Council to award 23 fellowships, subject to the availability of funds at a total cost of US\$151,445.00. Women account for 35% of the recommended applicants. Fifty percent of the recommended applicants are from Africa, 30% from Asia/Pacific and 30% from Latin America and Caribbean region. The recommended applicants are listed in the Appendix to this report. Also attached is the Fellowship Awardees for the Spring 2013 Cycle.

3. The Panel recommended that some of the former fellows in three geographic regions could be invited to and make presentation on their success stories at the next Session of the ITTC to be held in Yokohama in 2014 in conjunction with the commemorative events marking the 50<sup>th</sup> Session of the ITTC.
4. The Selection Panel members for the Year 2014 were also invited to the Panel meeting and were informed of the fellowship selection procedure and timeline for 2014. The 2014 Selection Panel is composed of:
