## Results of the initial review of applications of Observers to the Fifty-third Session of the ITTC for compliance with the requirements under Decision 3(LI)

In accordance with Decision 3(LI) on 'Matters related to admission of observers', operative paragraph 1, applications of observers for admission to the 53<sup>rd</sup> ITTC have to include the following elements:

- Description on relevance of the applicants to the objectives of the ITTA, 2006; and
- Declaration of acceptance of the Guidelines as set out in the Annex [to Decision 3(LI)]

In accordance with operative paragraph 2 of the Decision, the Executive Director has reviewed applications for compliance with the requirements, and the results are presented in the table below together with information on any previous ITTC session that observers have been approved to attend. The table includes all applications from observers received by the Secretariat up to the deadline for posting this document two weeks prior to the  $53^{rd}$  ITTC Session (note that the deadline for observer applications to be submitted to the Secretariat was 31 October 2017).
