INTERNATIONAL FORUM - Together Towards Global Green Supply Chains - A Forest Products Industry Initiative 22-25 October 2019, Shanghai and Huzhou, China

On behalf of the Organizing Committee, I hereby extend an invitation to you and your colleagues to attend the International Forum, "Together Towards Global Green Supply Chains — A Forest Products Industry Initiative", to be held on **22–25 October 2019** in Shanghai and Huzhou, China.

We are excited that the ITTO LSSC (Legal and Sustainable Supply Chain) Programme is making great progress with the organization of this International Forum, bringing together global forest industry leaders, governments and the international forest regime at this international forum, with participants anticipated from all regions of the world. Expected outcomes include an explicit commitment among relevant participating businesses to establish legal and sustainable timber supply chains, and the launch of a multi stakeholder platform for facilitating "green" business, exchanging information and aligning business standards.

Such supply chains will incentivize responsible production and purchasing practices while also leading to additional benefits in poverty alleviation, the creation of employment, economic growth, income generation, and substantial climate-change mitigation.
