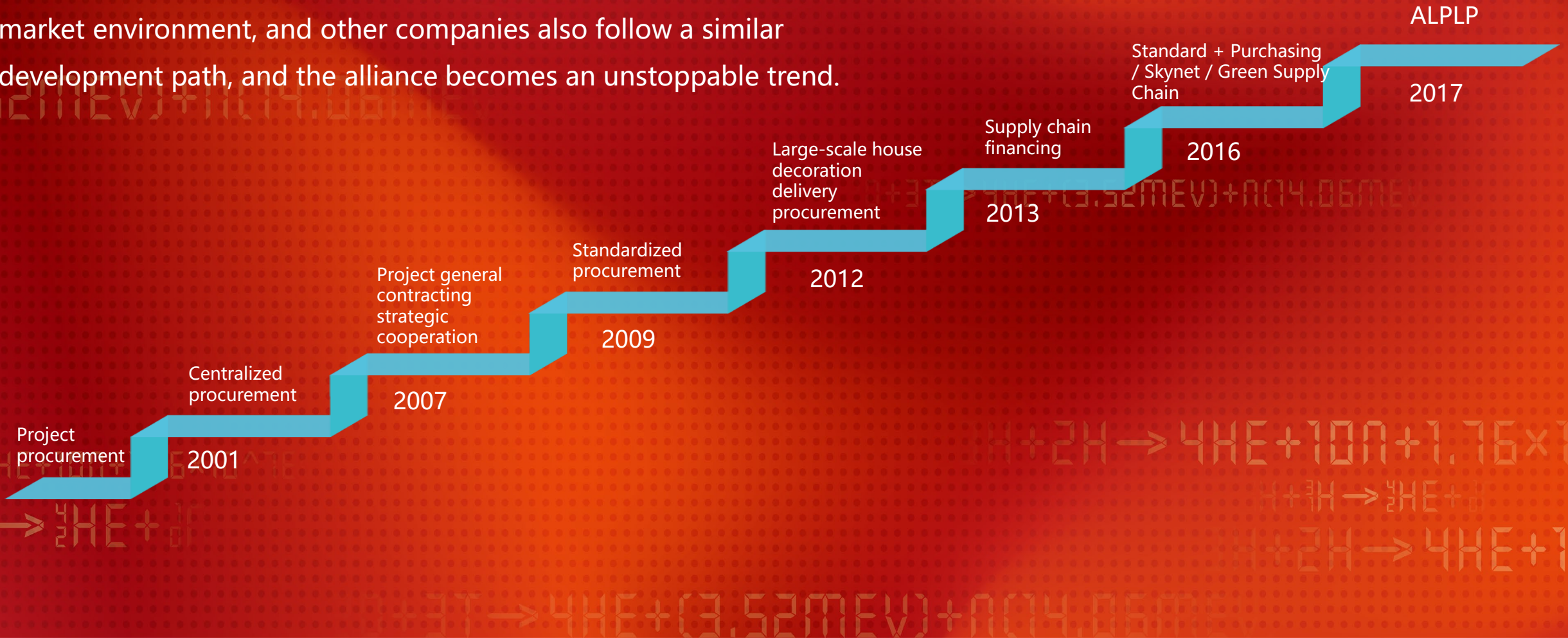

The way of procurement keeps changing following the changes of the market environment, and other companies also follow a similar development path, and the alliance becomes an unstoppable trend.



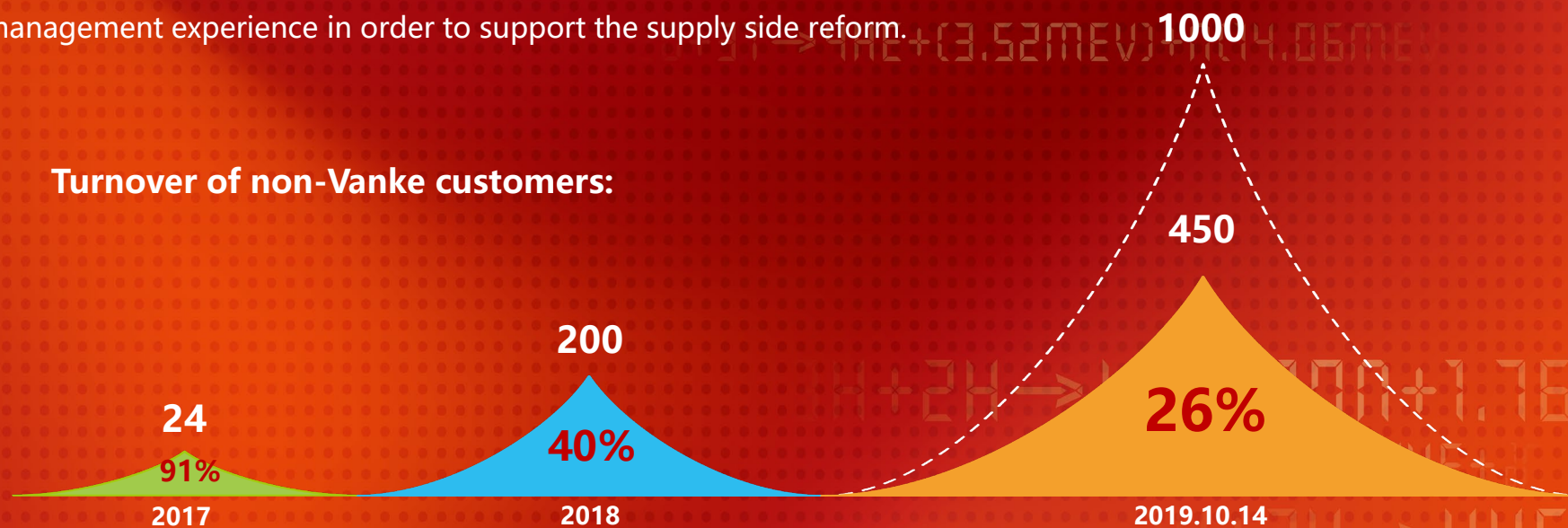


# The original intention of the establishment of the ALPLP was to unite

The ALPLP is a third-party procurement and B2B trading platform for building materials jointly initiated by Vanke, CURA Investment and Zhongtian Holdings Group. It tries to establish a new model of collaborative development of real estate supply chain that provides social services such as standard setting, joint bidding and quality inspection. It does not earn a difference in price. On the basis of more than 30 years of experience and practice in Vanke's new product development, quality control, supply chain management, etc., ALPLP improves industry procurement transparency, green procurement standards, and promote the level of real estate supply chain services, through sharing good resources and management experience in order to support the supply side reform.

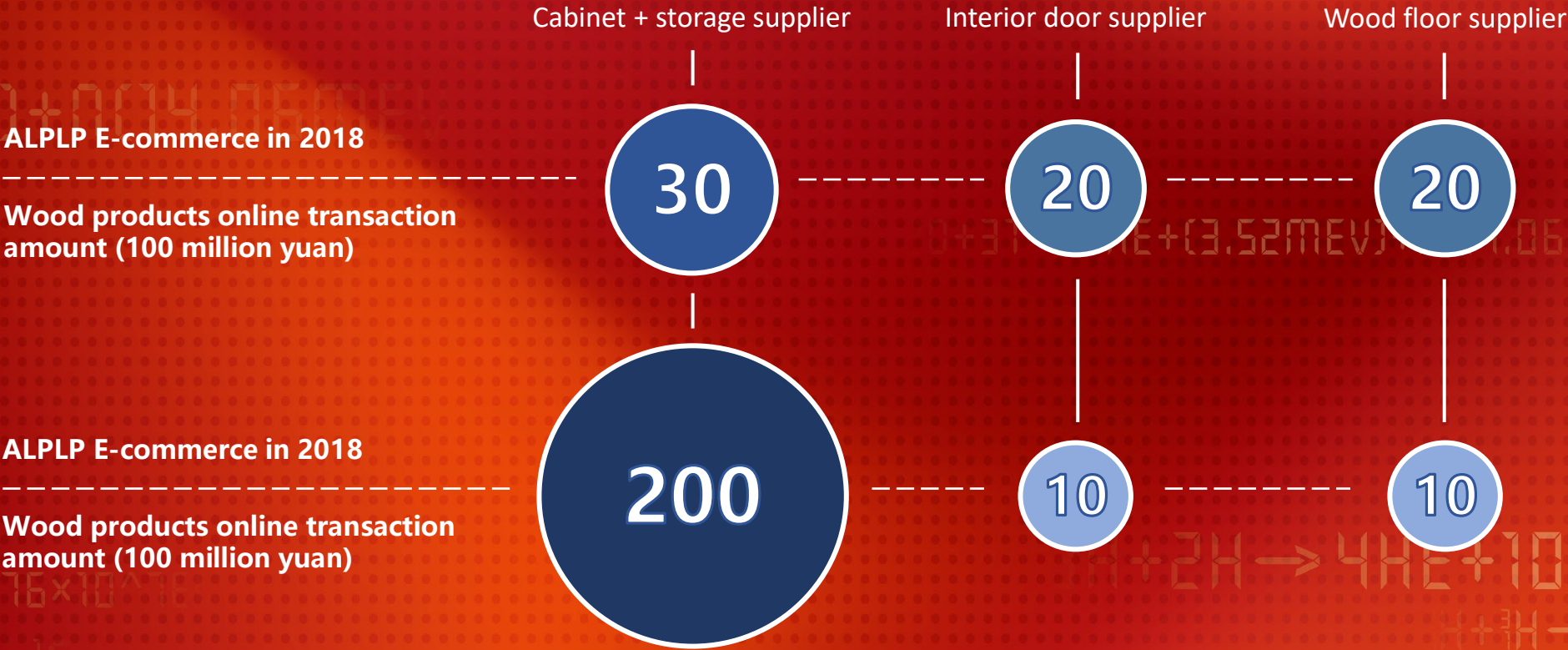

ALPLP not only provides procurement services, but also provides solutions for wood product suppliers. In the future, suppliers will develop from a single product to a multi-category.





# Timber legality, we are already in action

On December 28, 2011, four floor suppliers joined GFTN. ALPLP takes GFTN members (or promise to join GFTN within two years) as a prerequisite for floor tendering.

## Commitment:

### 1. Develop a responsible forest product procurement policy and not purchase forest products from the following conditions:

- Illegal harvested timber;
- Timber harvesting that violates the rights of indigenous and community residents;
- Timber harvested in threatened high conservation value forests;
- Timber from forests that is being converted to plantations or non-forest land;
- Forests using genetically modified trees.

### 2. Giving priorities to members of the World Wide Fund for Nature (WWF) Global Forest Trade Network (GFTN)

and members establishing standards for wood procurement policies and systems meeting the GFTN requirement. ALPLP takes this as the bottom line standard for bidding and cooperation.



# Green supply chain, we have been working hard

Under our influence, more flooring suppliers have joined GFTN and Vanke purchase 100% from those GFTN member companies.

# Green supply chain extension

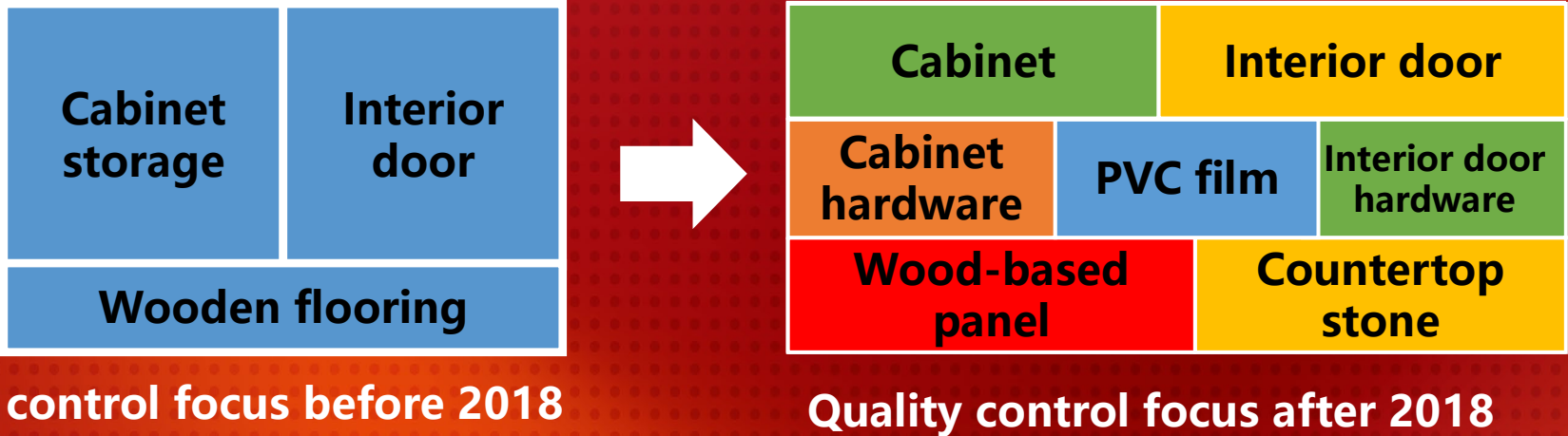
On June 5, 2016, the first batch of 48 companies joined the real estate green supply chain jointly created by SEE, CURA, CRECC, Vanke and Landsea. Vanke's three procurement standards (aluminum chrome-free passivation, legal wood origin, indoor formaldehyde control) were applied in the first batch of projects.

# Wood product quality management extends upstream

The procurement requirement of ALPLP will extend from wood processing companies to raw material suppliers. It will provide better quality, better environmental performance products, and serve end-use procurement customers.

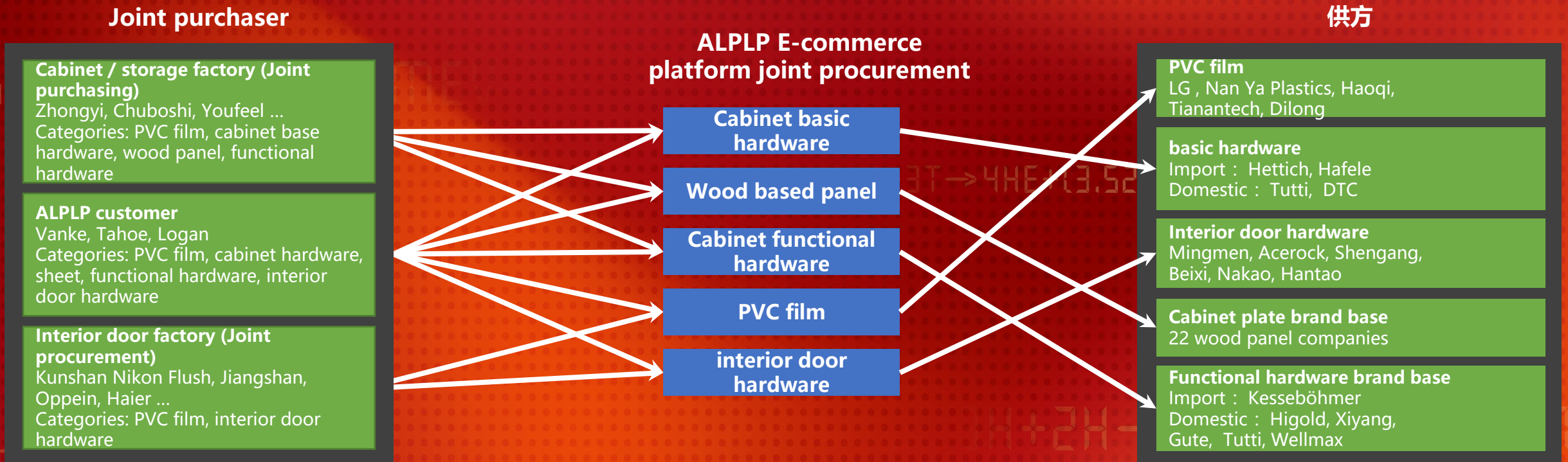

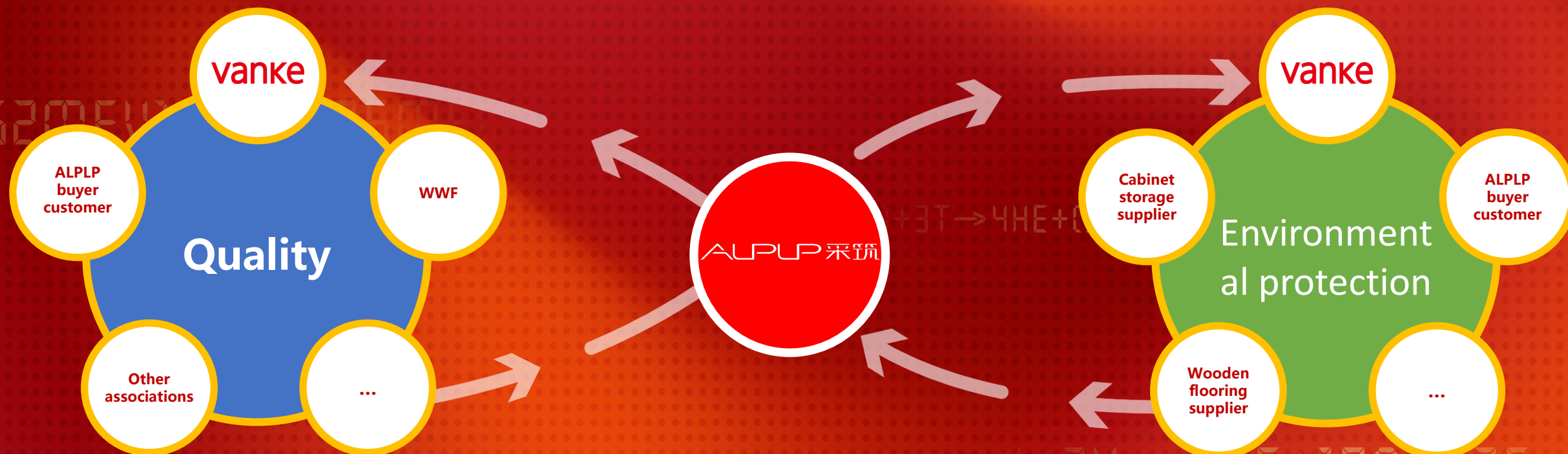
# Wood product supply chain management tracing upstream
