# REDD-plus Start-up Year 2020

## Roadmap to Result-based and Transferable Outcomes for Sustainable Development

### Objective

The seminar aims to overview the history of development and trend of both technical and institutional aspects of REDD-plus and explore current and future opportunities including international transfer of mitigation outcomes that will encourage participation and private sectors and contribute for countries to fulfill the Nationally Determined Contributions (NDCs) and to achieve Sustainable Development Goals (SDGs). It also will explore the opportunities under voluntary mechanisms to enhance climate change mitigation potentials including by the Joint Crediting Mechanism (JCM) which is proposed and started implementation by Japan and partner countries.

Since its establishment in 2010, REDD Research and Development Center of FFPRI-Japan has been conducting research and development of tools and guidance which help both public and private sector practitioners to understand and develop REDD-plus preparations and activities. In this seminar, outcomes of the 10 years' work by the Center will be disseminated in addition to the exchange of the knowledge and information provided by distinguished experts from various part of the world and discussions by the expert panel.

Participants are encouraged to display their panel presentation at the exhibition area in the venue as well. All of the day, there will be full of opportunities of exchanging and updating the latest information about REDD-plus that will promote the start-up in 2020 through forest based solutions which will contribute to sustainable development by a no-one left behind way.
