# PROGRESS REPORT ON THE IMPLEMENTATION OF THE ITTO BIENNIAL WORK PROGRAMME FOR 2018-2019 EXTENDED INTO 2020 – DECISION 3(LV)

#### [Item 12(a) of the Provisional Agenda]

This document is prepared pursuant to Council Decision 2(LIII), which requested the Executive Director to report on the implementation status of the ITTO Biennial Work Programme (BWP) for the years 2018 and 2019. The document contains the activities as approved in Council Decision 2(LIII), however the columns on 'Relevance' and 'Responsible Body' have been replaced by the column on the 'Implementation Status'. For information on 'Relevance' and 'Responsible Body' please see Annex 1. For the detailed terms of reference of each activity, please refer to the BWP 2018-2019 as approved in Council Decision 2(LIII).

With the adoption of Decision 3(LV) the BWP 2018-2019 was extended into 2020.

The Biennial Work Programme (BWP) 2018-2019, was adopted with Council Decision 2(LIII) and it was extended into 2020 through Council Decision 3(LV). It includes 41 activities divided into two parts. Part 1 includes 26 activities requiring financing through core budget, voluntary contributions or other sources. Part 2 includes 15 administrative and financial activities that do not require financing. With a view to provide a coherent structure, the activities under Part 1 have been categorized into the five groups according to their nature. The funding status of each activity is reflected in Table 1. Administrative and financial activities with no financial requirements (Activities 27-41) are not included.

The total funding sought under the BWP 2018-2019 is US\$9,870,000. Out of this amount, US\$1,840,000 has been approved under core operational costs through Decision 3(LIII) and US\$ 8,030,000 is sought from voluntary contributions. Activity 7 on Independent Market Monitoring (IMM) is fully funded by an EU Grant in the amount of Euro 4 million and is not included in the calculation of the contributions sought/pledged under this BWP.

At the time of preparing this report, total voluntary contributions in the amount of US\$8,663,161 have been pledged under the extended BWP, i.e., US\$821,799 in 2018, US\$4,598,934 in 2019 and US\$3,242,428 in 2020 (see Table 2). The total voluntary contributions pledged equal 107.9% of the voluntary contributions originally sought for the biennium 2018/2019.

The voluntary contributions pledged to the BWP in 2019 exceeded the amount originally sought under this BWP for that year, mainly due to two pledges from Germany, i.e. to Activity 2 (US\$2,390,000) and to Activity 5 (US\$1,236,390), in addition to pledges from China, EU, Japan, Korea, Netherlands and the USA. Contributions were also received in 2018-19 from the International Union for Conservation of Nature, IUCN; the Program for the Promotion of Certified Forest Operations, PPECF and the Bali Partnership Fund. Contractual contributions were received from the World Bank and the CITES Secretariat.

In 2020 voluntary contributions were received from China, Japan, the USA and from FAO. Under Activity 12 an additional sub-activity has been added with funding of US\$2,210,526 from the Government of Japan under its emergency assistance program for urgent actions for fire prevention and response.

While the total voluntary contributions received (US\$8,663,161) under the BWP 2018-2019 extended into 2020 exceed the amount originally sought (US\$8,030,000), a substantial number of activities have received only partial funding or remain pending finance. This is mainly due to the extension of the BWP for one additional year and the fact that two activities have received substantially more funding than originally sought, i.e., Activity 2 (sought US\$1,000,000; received US\$3,352,142) and Activity 12 (sought US\$100,000; received US\$2,230,526).

In summary, out of the 26 activities requiring financing, seven activities are fully funded through core budget and one activity (Activity 7, IMM) is fully financed through an EU Grant. In addition, five activities have been fully funded through voluntary contributions, ten activities have received partial funding and three activities remain pending finance. All contributions received under the BWP 2018-2019 extended into 2020 are summarized in Table 3.

#### Status, Progress, Achievements:

A brief summary of the status, progress and achievements of activities that have received partial or full financing is given below. A more detailed account is provided in the Progress Report table.

#### Group 1 - Field oriented activities with engagement of/work in member countries

#### Activity 1 – Incentives for green-growth value chain investments in tropical forests

The Secretariat collaborated with the World Bank and co-hosted a workshop on Fiscal Mechanisms for a Sustainable Forest Sector in Washington D.C. in late October 2018. Additional funding has been provided for full implementation of this activity as part of the Legal and Sustainable Supply Chains, LSSC pilot programme (Activity 2). These funds are being used to undertake case studies and/or pilot implementation of selected fiscal mechanisms in a range of ITTO producer countries and to undertake a global study of supply-demand gaps for tropical timber. While the work will be largely completed by the end of 2020 it has been impacted by the COVID-19 pandemic and it is expected to continue through 2021, pending approval of an extension request.

#### • Activity 2 - Building legal and sustainable forest product supply chains

This activity is part of the Legal and Sustainable Supply Chain, LSSC pilot programme. It has received funding from the Germany, Japan, USA, China and FAO. An update on the different components of this activity is included in Annex 2.

#### Activity 3 – Strengthening participation of the private sector in the work of ITTO: industry-led legality compliance/due care training

The Secretariat has been collaborating with the World Resources Institute (WRI) as well as the Global Timber Forum and FAO to undertake two training workshops for the Peruvian forest industry on complying with relevant market legality requirements in 2019. ITTO has agreed to extend this private sector training work to Guatemala during 2020; however the planned workshops have been postponed until at least late in the year due to COVID-19. Limited funds will also be provided to support virtual workshops for the private sector in Colombia.

#### • Activity 4 - Enhancing Teak Management

The 2<sup>nd</sup> Project Steering Committee Meeting and National Teak Forum "Sustainable Teak Value Chains for Sustainable Local Development" was held in Vientiane and Luang Prabang Provinces, Lao PDR in February 2020 back to back with a technical meeting for the Vietnam component for teak value chain assessment. Seven issues of the bi-monthly ITTO Teak Project's Newsletters have been published (<a href="http://www.teaknet.org/">http://www.teaknet.org/</a>). Due to the COVID-19 pandemic, the 4<sup>th</sup> World Teak Conference (WTC) was postponed from August 2020 to August 2021. During the conference, a special session on Sustainable Teak Management in Mekong Sub-region will be organized.

#### Activity 6 – Enhance cooperation between ITTO and CITES

ITTO signed contracts with the CITES Secretariat to receive funds totaling US\$ 576,483 under the CITES Tree Species Program (CTSP) through 2020. These contracts define ITTO's assistance to CITES in implementing the CTSP, including reviewing proposals submitted by ITTO members; convening 3 regional meetings; participating in the CTSP advisory committee; and supporting implementation of projects in ITTO member countries. Most CTSP projects have been impacted by the COVID-19 pandemic; the CTSP is likely to be extended through 2021 during which time ITTO will continue its collaboration.

#### Activity 7 – Independent market monitoring of FLEGT-licensed timber

In March 2020 the IMM Project Steering Committee (PSC) approved the 2020 Work Plan, which provided for continuation of activities launched in 2018 and 2019 as well as several new special studies and broadening of the correspondent network in VPA partner countries. Six IMM Trade Consultation workshops in key EU countries were completed in important European tropical timber markets by the

end of 2019. A seventh workshop was planned in Italy in May 2020, but had to be postponed due to the COVID pandemic, with a November 2020-date currently under consideration. Survey work undertaken by the IMM network of correspondents in the EU was limited to six countries in 2020, as market players in Spain were difficult to engage due to the limited trade volumes between Spain and Indonesia and delays in the start of FLEGT-licensing in African partner countries. In VPA partner countries, survey work continued in Indonesia and Ghana; new country correspondents were appointed for Congo Rep. and Vietnam in late 2019 and baseline studies commissioned for both countries in 2020. Two new special studies — a furniture sector follow-up study with focus on key Asian suppliers and a FLEGT impact on forest sector investment follow-up study with focus on Indonesia and Vietnam — were completed during 2020. Final reports on all IMM special studies can be found on the IMM website (https://www.flegtimm.eu/index.php/reports).

#### Activity 9 – Statistical capacity building workshops

FAO invited ITTO to participate in a national workshop on Forest products Statistics in Viet Nam, coorganized by the Viet Nam Administration of Forestry (VNFOREST) and supported by the Forest Resources and Environment Center. A regional statistical workshop covering all African ITTO member countries planned for September 2020, had to be postponed to 2021 due to COVID-19.

#### Group 2 - Normative work on policy guidelines or other strategic work

#### Activity 10 – Developing and operationalizing ITTO's policy guidelines to members

- (a) A discussion panel led by CSAG, focusing on the role of women in achieving ITTO's objectives, including constraints and opportunities was held during the 54<sup>th</sup> ITTC. The Secretariat sponsored and conducted a preparatory meeting of Togolese women for the establishment of a REFACOF chapter in Togo. A panel 'Enhancing the Role of Women in Forestry' was held during the Trade and Markets Day at the 55<sup>th</sup> ITTC. CSAG has also been supported to participate at TICAD 7 in Yokohama, Japan to advocate the interests of women in the forestry sector. Several articles highlighting the role of women in forestry have been published in TFU, with issue 28/1 (2019) focusing on this topic.
- (b) The Guidelines for Forest Landscape Restoration in the Tropics were adopted based on Decision 7(LV) and the publication of the Guidelines in English, French and Spanish is being finalized with a policy brief highlighting key elements of these Guidelines. The Asia-Pacific Regional Workshop for FLR 'From principles to action on the ground' was planned in Myanmar in March 2020 as a joint effort between ITTO and IUFRO under the Tier 2 of the CPF Joint Initiative on FLR. However, this workshop has been postponed due to the COVID-19 pandemic.

#### Activity 11 - Formulate a new Strategic Action Plan

Due to the COVID-19 pandemic, it has not been possible to conduct necessary consultancy work, consultations or to convene a Working Group for the preparation of a draft ITTO Strategic Action Plan for consideration of the Council. Provided that the situation improves and allows for such work to be conducted in 2021, a draft ITTO Strategic Action Plan will be submitted for Council's consideration at the ITTC 57.

#### Group 3 - Collaborative work/meetings with other organization/initiatives

#### Activity 12 - Prevention and management of fire in tropical timber-producing forests

ITTO participated in the 7<sup>th</sup> IWFC "Facing Fire in a Changing World: Reducing Vulnerability of People and Landscapes by Integrated Fire Management" in Campo Grande, Brazil, 28 October - 1 November 2019. Assistance has been provided for the participation of five forest fire experts from Ghana, Indonesia, Panama, Peru, and Vietnam. Under this activity and an additional sub-activity has been added with funding of US\$2,210,526 from the Government of Japan, provided under its emergency assistance program for urgent actions for fire prevention and response.

#### • Activity 14 - Cooperation and consultation with the CPF, UNFF and others

ITTO collaboration with CPF members has been strengthened concerning forest landscape restoration and through the 'Sustainable Wood for a Sustainable World' (SW4SW) initiative adopted in May 2018 as a Joint Initiative of CPF. ITTO co-organized a side-event "Forest-based solutions in the tropics for combating climate change and achieving the SDGs" with Forest and the Forest and Forest Products Research Institute of Japan (FFPRI) at UNFCC COP 25 in December 2019. The Secretariat is planning to participate in and assist the participation of experts in CBD COP 15 related meetings in 2021 to provide technical inputs to the Post 2020 Global Biodiversity Framework.

#### • Activity 15 - Collaboration on criteria and indicators for SFM

Planned meetings of the FAO FRA Advisory Board and other C&I related meetings have been postponed or held virtually in 2020 due to COVID-19. ITTO will participate in a virtual roundtable on the FRA 2020 report during FAO's COFO virtual meeting in October 2020.

#### Group 4 - Communication and outreach-related work

Activities under Group 4 have resulted in a broad range of products. These included, among others, publications, videos, newsletters, social media posts, exhibition booths, website updates, promotional materials and lectures. Noteworthy accomplishments include the relaunch of the ITTO's website with a new look and intuitive navigation and a new design for TFU. The Secretariat expects to engage a communications consultant to assist in the development of the ITTO Communications Strategy in the last quarter of 2020 and work on developing the strategy in 2021. The TFU is distributed in hard copy to about 14 000 individuals and organizations in more than 160 countries. The e-newsletter Tropical Forest News has more than 2,700 subscribers.

#### Group 5 - Analytical, statistical and other recurring work

# Activity 19 – Trade (TAG) and Civil Society (CSAG) Advisory Group involvement Assistance has been provided by the Secretariat for the participation of CSAG and TAG at the 54<sup>th</sup> and 55<sup>th</sup> ITTC.

#### Activity 20 – ITTO Annual Market Discussion

The 2019 Market Discussion on the theme "Added Value Processing in Africa - The Opportunities and Challenges" took place during the new "Trade and Markets Day" as part of the 55<sup>th</sup> ITTC held in Lomé, Togo. The theme for the next Annual Market Discussion proposed by the Trade Advisory Group (TAG) is "Resilience in Trade: Timber Sector and COVID-19". Due to the pandemic the TAG recommended postponing the 2020 Annual Market Discussion until Council is convened with representatives of member countries and the trade able to participate physically.

#### • Activity 21 - Expert Panel for the Technical Appraisal of Project Proposals

The 54<sup>th</sup> Expert Panel was convened in Yokohama, Japan on 24-28 June 2019. The report will be presented to the Joint Committees under JC Agenda Item 1 [Document ITTC/EP-54]. Due to COVID-19 the 55<sup>th</sup> Expert Panel was conducted electronically. The report will be presented to the Council under Item 20(a) of the Provisional Agenda (Document ITTC(LVI)/12)

#### Activity 22 – ITTO Fellowship Programme

The Progress report on the implementation of the ITTO Fellowship Programme [Document ITTC(LVI)/5] will be included under Item 12(a) of the Provisional Agenda Item. The Fellowship Selection Panel will meet prior to the Fifty-sixth Session of the Council and will make recommendations for awards under the Fellowship Cycle 2020 to the Council.

#### Activity 23 - ITTO Market Information Service (MIS)

Twenty-three issues of the Tropical Timber Market Report (TTMR) have been published in 2018 and 2019 each and are planned for 2020. The report is distributed to over 18,000 registered readers.

#### • Activity 24 - Enhancement of statistical work and databases on statistics

In 2020, the Inter-secretariat Working Group on Forest Statistics (IWGFS) was held in Geneva. Main topics discussed were the continuous improvements of the Joint Forest Sector Questionnaire, the inclusion of new forest products conversion factors inside the current statistical systems of the participating organizations, the implementation of automatic procedures for reducing trade discrepancies and the presentation of ITTO procedures for automatically downloading data from the UN trade statistics database (COMTRADE).

#### • Activity 25 - Biennial review and assessment of the world timber situation

The draft elements for the Biennial Review and Assessment of the World Timber Situation for 2017-2018 were presented to and considered by the 54<sup>th</sup> ITTC. The Biennial Review and Assessment of the World Timber Situation 2017-2018 was published in September 2019 and complemented with an analysis of the Japanese timber market undertaken by the Japan Wood-products Information and Research Center (JAWIC). The ITTO online statistical database was updated in July 2020 with the most current production and trade figures for primary wood products and for the trade of secondary wood products covering the period 1990-2019.

The draft elements for the Biennial Review and Assessment of the World Timber Situation for 2019-2020 will be presented to and considered by the 56<sup>th</sup> ITTC, with the final Biennial Review to be published by June 2021.

#### Administrative and financial activities (no financial requirements)

Under this category, 15 activities have been approved. All activities are categorized as 'regular sessions work'.

#### ANNEX 2

#### Activity 2 - Building legal and sustainable forest product supply chains Implementation Status of the Legal and Sustainable Supply Chain, LSSC pilot programme

Incentives for green-growth value chain investments in tropical forests

- The initial analysis of two countries summary of key lessons is ongoing in the Republic of Congo and in Gabon:
- Contracts have been signed with the lead consultant (who will also carry out the Africa case study) and the consultants who will carry out the supply-demand gap study; contracts have been finalized and sent to the consultants who will carry out the Asian and Latin American case studies;
- Demand-supply gap analysis with a global view and specific conclusions in selected lead markets important for the case countries (forest economist/econometrician sub-contracted) is underway;
- In-country preparation of case studies (country experts' review and interviews on incentives; preparations of case narratives) is underway in the Republic of Congo and in Gabon;

Supporting the establishment and operation of the Global Legal and Sustainable Supply Chain (LSSC) Platform

- The International Forum "Together towards Global Green Supply Chains a Forest Products Industry Initiative" was held on 22–25 October 2019 in Shanghai and Huzhou, China. Around 350 participants from government agencies, international organizations, industry associations, and private sector enterprises attended this conference and related events.
- Main outputs of this forum included an initiative on Building a GGSC Collaboration Network, a MoU
  between UFIGA and UFIAG of Gabon for legality and sustainability verification within a three-year
  period, establishment of an international entrepreneurs' expert team, etc.
- The establishment of the Business Information Exchange Platform has commenced, including building of the LSSC-GGSC website, initiating the GGSC expert panel, designing and preparing for the business information exchange index, etc.
- During the Shanghai Forum a meeting was held with the Global Timber Tracking Network, GTTN
  discussing the coordination of GTTN Phase III from 2020 onwards and the possible integration of
  GTTN as a key component of the GGSC platform under the LSSC programmatic line.
- The function and structure of the LSSC-GGSC website has been constructed. The website has
  initiated online with Chinese and English versions available and the French version and other
  improvements are being developed.
- The Business Information Exchange (GGSC) Index has been designed and initiated. The index data
  has been collected from more than 30 Chinese enterprises since January 2020 and published
  monthly on the GGSC website. Five African timber enterprises began to provide data since April
  2020 but were being affected by COVID-19 until now.
- The GGSC business information exchange platform has been initiated and developed. GGSC communicated with timber associations of more than 10 countries and agencies. Some of these associations have been keeping periodical communications with GGSC Secretariat.
- A study of the Blockchain-based International Timber Tracking System has been approved and commenced, with the funds reallocated from Madagascar rosewood activity (formal Activity 4). The implementation is well on track and blockchain architecture as well as a blockchain technology applicable to the timber tracking system were identified and introduced. However, field simulation testing in Africa has been delayed due to COVID-19.

Promotion of smallholders' forest landscape restoration in West Africa

- Six national consultants had conducted country studies (Benin, Cote d'Ivoire, Ghana, Liberia, Mali and Togo) in West Africa under the guidance of the international lead consultant, Professor Jürgen Blaser, Bern University of Applied Sciences;
- The lead consultant and his team have collected FLR policies and successful FLR case stories in the region for comprehensive analysis and assessment of the scalable solutions and good organizational practices:

- A regional workshop on sustainable development of smallholder FLR plantations in West Africa
  was organized in collaboration with the Office for Forest Development and Exploitation, ODEF,
  Togo and was held on 27 29 November 2019, in Lomé, Togo prior to the 55<sup>th</sup> ITTC. The
  workshop was attended by about 50 people from governments, the private sector and civil
  societies in ITTO African member countries. Key outcomes of the regional workshop were
  presented at Market Discussion Session of the 55<sup>th</sup> ITTC.
- Each of six country studies still needs to validate the national recommendations, which were presented and discussed during the regional workshop. National validation workshops had been planned in the first quarter of 2020 but they could not take place due to the COVID-19 pandemic. Weak internet access could make virtual workshops complicated, especially for some countries (Liberia, Benin) and in particular for specific stakeholders (small entrepreneurs, communities). Togo national consultant, Prof Kokou, University of Lomé, and the team of experts led by Professor Juergen Blaser had been interacting with ITTO focal points in these six countries on the ways and means to organize some kind of virtual workshops or a hybrid system combining virtual and inperson attendance. Although the extension of the implementation period has been made until December 2020, the team of experts expressed the need for a further extension (April/May 2021) considering that the situation of COVID-19 pandemic has not significantly changed in these six target countries covered by the implementation of BMEL-Activity-3.

From rosewood stockpiles towards legal and sustainable management of supply chains in Madagascar

• This activity was cancelled in agreement with BMEL following inability to reach agreement with the Government of Madagascar on the proposed activity. Funds allocated (\$300,000) were reallocated to the LSSC activity (see above).

Development of training curricula for Central African countries on legal and sustainable supply chains

- The inception regional workshop dealing with the sensitization and awareness on legal and sustainable supply chains (LSSC), in relation to forest governance in Congo Basin countries, was held on 14-15 October 2019 in Douala (Cameroon).
- Four consultants have prepared the draft of training modules/curricula to be subject to the validation process with the holding of validation workshops planned in October 2020. These four training modules/curricula are, as follows:
  - Module/curricula 1: Understanding deforestation-free
  - Module/curricula 2: Assessing legality and achieving accountability
  - Module/curricula 3: From legality to sustainability
  - Module/curricula 4: Markets and access to markets
- For the preparation of logistic aspects of workshops for the validation of the abovementioned four LSSC-related training modules/curricula, the RIFFEAC Secretariat is interacting with the ITTO focal points for the holding these workshops taking into account that the COVID-19's restriction measures are gradually relaxed by ITTO member countries in the Congo Basin region (Cameroun, Central African Republic, Congo-Brazzaville, Congo-Kinshasa and Gabon).
