<u>Item 1 - Opening of the Session</u>

Item 2 - Adoption of Agenda and Organization of Work

The Committee may consider the Provisional Agenda and adopt the Agenda for the session. On the organization of work, it is to be noted that the schedule of meetings for the work of the Committee will be determined after usual consultations. The Committee may also constitute the usual informal open-ended working group(s) to assist in the consideration of specific matters related to the Agenda. Due to the ongoing consultations with the Informal Advisory Group regarding logistics of convening the Fifty-seventh ITTC Session virtually, additional communications regarding how/whether items on the Committees' agenda will be handled will be communicated to members as relevant decisions are taken and/or at the start of the virtual session.

Item 3 - Admission of Observers

The Committees may admit those observers as approved by the Council to attend the session as observers.

<u>Item 4 - ITTO Annual Market Discussion - 2021</u>

The theme of the virtual ITTO Annual Market Discussion - 2021 as proposed by the Trade Advisory Group (T-A-G) is "Challenges in the COVID-19 pandemic". The Market Discussion will be convened under the Council (rather than under a session of the Joint Committees) as an extraordinary measure during the virtual ITTC 57 session. An information note detailing the schedule and speakers for the ITTO Annual Market Discussion - 2021 will be circulated prior to the session.

<u>Item 9 - Ex-post Evaluations</u>

In 2020-2021, the ex-post evaluation of Thematic Group dealing with Biodiversity Conservation and Conservation Areas was carried for the assessment of the ITTO-CBD Collaborative Initiative for Tropical Forest Biodiversity covering and analyzing the achievements of sixteen ITTO projects under the ITTO-CBD Collaborative Initiative. The assessment also aimed at providing recommendations for the extended activities of the Collaborative Initiative to contribute to the SDGs, the UN Decade for Ecosystem Restoration 2021-2030, and the Post-2020 Global Biodiversity Framework.

The Committee may consider the results of the assessment of the ITTO-CBD Collaborative Initiative for Tropical Forest Biodiversity in the context of the ex-post evaluation of Thematic Group dealing with Biodiversity Conservation and Conservation Areas, as contained in document CRF(LV)/4.
