Item 2 - Adoption of Agenda and Organization of Work

The Committee may consider the Provisional Agenda and adopt the Agenda for the session. On the organization of work, it is to be noted that the schedule of meetings for the work of the Committee will be determined after usual consultations. The Committee may also constitute the usual informal open-ended working group(s) to assist in the consideration of specific matters related to the Agenda. Items 4, 6 and 9(A) of the Agenda will be considered at a joint session of the Committees.

Item 3 - Admission of Observers

The Committees may admit those observers as approved by the Council to attend the session as observers.

Item 4 - ITTO Annual Market Discussion - 2023

This item will be taken up in the joint session of the Committees, as part of a Trade and Markets Day during the session (an agenda for the proposed Trade and Markets Day will be circulated prior to the session). The theme of the ITTO Annual Market Discussion - 2023 as proposed by the Trade Advisory Group (TAG) is "Tropical Timber Industry: Challenges and Opportunities from Changing Priorities". Item 9 - Ex-post Evaluations

(A) Ex-post Evaluation Report

[Document CRF(LVII)/5]

The Committee may recall that, at its last Session, an ex-post evaluation of recently completed ITTO projects in forest landscape restoration (FLR) was selected.

A thematic group evaluation was carried out by one consultant [Dr Suneetha Subramanian, United Nations University Institute for the Advanced Study of Sustainability (UNU-IAS)] to assess the achievements of selected completed and on-going ITTO projects in FLR. The focus of the evaluation is to assess the impacts of integrating gender perspectives, particularly the empowerment of women in these ITTO projects in relation to the ITTO *Guidelines for Forest Landscape Restoration in the Tropics and* the ITTO *Policy Guidelines on Gender Equality and Empowering Women*.

The outcomes of this evaluation will be published as a policy report in a joint publication between ITTO and UNU-IAS to highlight the lessons learned from the implementation of ITTO FLR projects as well as to promote the implementation of the ITTO Guidelines for FLR and gender.

(B) Selection of Projects for Ex-post Evaluations 2024

The Committee, during its 55th Session, approved the shortlist of ex-post evaluations for the year 2022-2023, as outlined in document CRF(LV)/5. Within this list, some projects had previously undergone assessments as part of the thematic group evaluation in forest landscape restoration (FLR).

In planning the ex-post evaluations for the year 2024, the main emphasis is to carry out the ex-post evaluation of the two completed forest fires projects in Indonesia and Peru. These evaluations are intended to provide an in-depth analysis of the lessons learned from the implementation of these two fire projects. The projects under the 2024 ex-post evaluation are the following:

- 1) PP-A/56-340-1 Capacity Building on Forest and Land Fire Management in Indonesia
- 2) PP-A/56-340-2 Forest Fire Prevention and Response in Tropical Forests and Forest Plantations in Peru

In addition, the evaluation for the year 2024 includes advancing the progress of the thematic Group Evaluation on Forest Rehabilitation / Landscape Restoration / Secondary Forest Management, aligning the approval of the 55th Session of the Committee. This is designed to evaluate the selected projects, with a concentrated focus, including the assessment of benefit-sharing mechanisms and the assessment of natural regeneration processes.

The selection of projects for ex-post evaluations for the years 2025-2026 will be presented to the Committee during its 58th Session in 2024, where the thematic groups for evaluations will be determined.

Item 10 - Review of Projects, Pre-projects and Biennial Work Programme-based Activities in Progress [Document CRF(LVII)/3]
