# Advancing Sustainable Forest Management: Financing Mechanisms for Carbon and Biodiversity

5 December 2023, 16:45–18:15 COP28 Official Side Event Venue- SE Room 9 Dubai, United Arab Emirates

#### Introduction

Tropical forests are vital for climate change mitigation and adaptation, storing immense amounts of carbon and contributing significantly to global biodiversity. These forests are a natural capital on which the livelihoods of many people depend. However, deforestation poses a growing threat, with an alarming annual loss of approximately 10 million hectares of forests from 2015 to 2020.

To address this challenge, sustainable financing is essential, focusing on carbon sequestration and biodiversity conservation through the effective management of forest resources as a nature-based solution. This necessitates an integrated approach, leveraging various financing mechanisms, from voluntary contributions to carbon market instruments.

Diverse sources of funding are indispensable for supporting a wide range of initiatives, from effective policy formulation and establishing robust legal and institutional governance frameworks, including monitoring, reporting and verification systems, to facilitating various capacity building for local stakeholders. Increased and sustainable financing is critical for reducing deforestation, conserving and managing forests, enhancing ecosystem services, and strengthening social-ecological resilience.

#### Main Objectives of the event

This event aims to discuss the significance of implementing forest-based solutions to climate change and the critical role of establishing sustainable financial mechanisms to support climate change mitigation and adaptation, and biodiversity conservation. Discussions will center on the goal of enhancing forest carbon contributions and generating tangible socio-economic benefits, with a particular focus on the well-being of Indigenous Peoples and local communities by exploring sustainable financing mechanisms to secure the future of our forests.

## Modalities and reporting of the event

This event will take place at the official side event venue of COP28, and conducted in English without interpretation services. Following the presentations by all speakers, a panel/open discussion will address two guiding questions.
