INTERNATIONAL TROPICAL TIMBER ORGANIZATION (ITTO)

The International Tropical Timber Organization's mission



- Promote the sustainable management and conservation of tropical forests.
- Promote the expansion and diversification of trade in tropical wood from sustainably managed and legally harvested forests.


ITTO is the sole intergovernmental organization focused entirely on tropical forest resources.



ITTO's facts and figures



- An intergovernmental organization established in 1986 under auspices of UNCTAD.
- The International Tropical Timber Agreement, 2006—the current treaty under which ITTO operates.
- ITTO members under ITTA, 2006—76 members:
 - Producing (37) and Consuming (39)
 - Producing members:
 - Africa (14)
 - Asia & Pacific (10)
 - Latin America (13)
 - Covering over 80% of global tropical forests and account for 90% of trade in tropical forest products.

ITTO's facts and figures (continuation)





- ITTO develops international policy documents and guidelines to promote sustainable forest management and forest-based enterprises:
 - Implemented and adapted to local conditions through field projects.
- ITTO collects, analyzes and disseminates data on the production and trade of tropical timber and is the foremost source of information, statistics and trends related to the global tropical timber economy.
- ITTO has funded more than 1200 projects/activities valued at USD 430 million, across the tropics—covering a wide spectrum of topics—enhancing the capacity of tropical countries to sustainable manage their forest resources.

ITTO 2023 Annual Market Discussion

Organised by the ITTO Trade Advisory Group, the theme of the Market Discussion was "Tropical Timber Industry: Challenges and Opportunities from Changing Priorities".

Presentations fell into three broad categories, forest products in a bioeconomy transition, smallholders and their overwhelming production for African and Asian domestic markets and implications for producers and importers from the EU Deforestation Regulation (EUDR).


To conclude the Market Discussion the Trade Statement was presented to the International Tropical Timber Council by the Trade Advisory Group.

A new frontier for SFM

In Central and West Africa and in some Asian countries small-scale timber production is informal, organised but unregulated. Artisanal millers are responding to growing national and regional demand and the volumes produced in the informal sector in most countries are greater than by the industrial sector.

Artisanal millers contribute little to national accounts but do they generate significant employment. Given the scale of production and that the artisanal sector is unregulated what are the implications for tropical forest harvesting? Is this the new frontier for tropical forest security and sustainable management?

The International Tropical Timber Council



- It is ITTO governing body —comprised by all members.
- It meets once a year to discuss wide-ranging agenda aimed at promoting sustainable tropical forest management and the trade of sustainably produced tropical timber.
- The Council is assisted by 4 committees and 3 advisory bodies:
 - Committee on Economics, Statistics and Markets,
 - Committee on Reforestation and Forest Management,
 - Committee on Forest Industry and
 - Committee on Finance and Administration.
 - Informal Advisory Group,
 - Trade Advisory Group and
 - Civil Society Advisory Group

LLSC online course—an ITTO contribution on global forest education





• ITTO June 2021—launched a free online learning course on legal, sustainable timber supply chains (LSSC).

Four modules:

- Sustainable forest management, reduced impact logging and forest landscape restoration,
- Timber legality assessment,
- Meeting legality requirements for ensuring sustainable outcomes, and
- Marketing for expanding, maintaining and forest businesses.
- The course highlights sustainable use of forest resources—essential for protecting biodiversity and maximizing the contributions of forests as nature-based solutions to climate change.
- Raising awareness of sustainable production and consumption.
