# FOURTH & FINAL ANNOUNCEMENT GLOBAL LEGAL AND SUSTAINABLE TIMBER FORUM, GLSTF 2024

# 11-12 SEPTEMBER 2024 MGM COTAI, MACAO SAR, CHINA

# **Background**

Recent development shows that the timber industry needs to collaborate even more closely among stakeholders including timber producers, buyers, processing industry and market players nationally and internationally. It must address issues in global timber supply chains arising from the post-pandemic and other uncertainties and must bridge the widening gap between demand and supply for wood products. It is also essential to sustain and enhance collaboration and exchange views and information, among timber industry stakeholders worldwide with the aim to building a sustainable collaborative platform in promoting legal and sustainable timber supply chains.

The ITTO's Legal and Sustainable Supply Chain (LSSC) Programme is aimed at building legal and sustainable supply chains. As part of the LSSC Program, ITTO and Macao SAR Commerce and Investment Promotion Institute (IPIM) are partners under a collaborative framework agreement to co-host the Global Legal and Sustainable Timber Forum (GLSTF), to accelerate the development of legal and sustainable timber supply chains.

The GLSTF inaugural forum 2023 was held on 21-22 November 2023 in Macao by the ITTO and IPIM in collaboration with the Global Green Supply Chains Initiative (GGSC). The GLSTF 2023 was the first global forum under this partnership focused on measures to be considered to improve the legality and sustainability of tropical timber supply chains. This milestone event brought together nearly 700 participants from 36 countries. The GLSTF 2024 is scheduled in September 2024 in Macao, providing continuity on these efforts on an annual basis.

# **Objective**

The GLSTF 2024 aims to enhance networking, collaboration, and business exchange among timber industry stakeholders - producers, buyers, processors and market players to strengthen support for sustainable forest management, and the uptake of legal and sustainable wood product supply chains to facilitate the legal and sustainable use and trade of wood products in a stable, transparent and predictable business environment while contributing to sustainable development and climate-change mitigation.

11 - 12 September 2024 at the MGM COTAI, Macao SAR, China.

# Co-hosts & Organizer

The GLSTF 2024 will be co-hosted by the ITTO and the IPIM and organized by the Secretariat of the GGSC. Specialized sub-forums will be co-organized by partner agencies and the ITTO, the IPIM and the GGSC.

### **Forum Structure**

The GLSTF 2024 will have two components:

- The Global Legal and Sustainable Timber Forum (main forum).
- Four Specialized Sub-forums (sub-forums).

# **Theme & Topics**

The theme of the GLSTF 2024 will be "Together Towards Reliable and Effective Global Timber Supply Chains".

The main forum will discuss topics related to reliable and stable timber resource supplies, trust and effectiveness along the timber supply chains and prospects for revitalizing global timber supply chains.

The specialized sub-forums will be organized by partner agencies, contributing to the theme, with selected topics on timber legality and sustainability; sustainable timber resources, markets and trade; advanced technology and machinery for wood processing; green finance and innovative facilitating measures.

# Legal and Sustainable Timber Industry Display

A legal and sustainable timber industry display will be organized in parallel with the GLSTF 2024, at a scale of around 30 booths.

## **Other Events & Activities**

The achievements of the Global Timber Index (GTI) and the Blockchain-based Timber Tracking System (BTTS) as well as others will be released at the GLSTF 2024. Other business activities and side events, such as B2B matchings, will be arranged accordingly.

# **Participants**

The GLSTF 2024 is expected to attract around 700 participants from wood enterprises and trading companies, industrial and business associations, governments, international organizations, research institutions, etc.

## Languages

The Global Legal and Sustainable Timber Forum 2024 main forum will feature simultaneous interpretation in Chinese, English, French, Spanish and Portuguese. The 4 Specialized Sub-forums will feature simultaneous interpretation in Chinese, English and French.

# 9 VISA REQUIREMENTS

# 1. Visa Requirements (Macao)

#### A. Immigration Requirements

Participants are advised to contact the nearest Embassy or Consulate of China regarding immigration requirements. For your information, the Border Control Department of the Macao Public Security Police Force keeps a record of the entry and exit of non-local residents on computer, as well as on their passport, travel document or other appropriate document, indicating the limit of stay granted. If necessary, the Department will also collect bio data so as to confirm or verify identities. The Public Security Police Force is a department responsible for immigration control in the Macao Special Administrative Region.

#### **B. Entry Requirements**

For entry to the Macao SAR, non-residents are required but not limited to meet the following requisites as well:

- In possession of a passport, travel document or other document accepted for the purpose of immigration control, and the document should be valid for at least 90 days beyond the period of intended stay in the Macao SAR;
- By means of a visa or other special advance procedures, or under the circumstances that such procedures are exempted, obtain the corresponding administrative authorization upon arrival at the Macao SAR;
- Confirmed that there is no entry refusal reason as prescribed by law upon actual entry to the Macao Special Administrative Region.

Visitors are required to possess a valid onward or return ticket unless they can prove that they reside on the Mainland of China or in the Hong Kong SAR. The exemption is not applicable to Chinese passport or Hong Kong SAR passport holders who transit Macao to another country or region;

Proof of possessing at least MOP5000 as means of subsistence in Macao if the period of intended stay is 7 days, at least MOP10,000 if the period of intended stay is 8-14 days.

#### C. "Visa" and "Entry Permit" Exemption

**Europe:** Albania, Andorra, Austria, Belarus, Belgium, Bosnia and Herzegovina, Bulgaria, Croatia, Cyprus, Czech, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Macedonia, Malta, Moldova, Monaco, Montenegro, Netherlands, Norway, Poland, Portugal, Romania, Russia, San Marino, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, United Kingdom

#### D. Visitors Who are not Exempted from a Visa and Entry Permit

#### Visitors who are not exempted from a visa and entry permit are required to:

Apply for an "Entry Permit" (aka "Visa-upon-arrival") at any of the border checkpoints of the Border Control Department of the Public Security Police upon arrival at Macao; or Apply, by a representative, to the Residence and Stay Affairs Department in advance for "Authorization to Enter and Stay"; or Apply for a 'visa' of the Macao Special Administrative Region in advance through a diplomatic mission of the People's Republic of China or a representative office accredited by the Ministry of Foreign Affairs of the People's Republic of China (visa sample) (Note: Starting from 1 July 2010, visitors from Bangladesh, Nepal, Nigeria, Pakistan, Sri Lanka and Vietnam are required to apply for a Macao visa in advance through a Chinese embassy or consulate).

- Application for an "Entry Permit" (aka "Visa-upon-arrival")
- Persons who intend to enter the Macao Special Administrative Region but have not applied in advance to any diplomatic mission of the People's Republic of China or representative office accredited by the Ministry of Foreign Affairs of the People's Republic of China for a 'visa', or to the Residence and Stay Affairs Department of the Macao Public Security Police Force for Prior Authorization to Enter can apply for Authorization to Enter and Stay (so-called 'visa-upon-arrival') at the Visa Room of the checkpoint upon arrival at Macao. They will also be granted Authorization to Stay for a maximum of 30 days once the application is approved.

# **GENERAL INFORMATION ABOUT MACAO**

#### General

Macao consists of the Macao Peninsula and the islands of Taipa and Coloane. Three bridges connect the peninsula and Taipa, while reclamation brings the two islands together. The area of Macao continues to expand, now spanning over 30 square kilometres. Despite its small size, it accommodates almost 700,000 people, making it one of the densest cities in the world. 90 percent of Macao population is Chinese, and the rest are Portuguese and Filipino. The official languages are Chinese and Portuguese, but most people can communicate in Cantonese, Mandarin and English.

#### Weather

September is relatively comfortable compared to the hot summer months. The average temperature in September for a typical day ranges from a high of 30°C to a low of 25°C.

#### **Time Zone**

Macao is eight hours ahead of Greenwich Mean Time.

## **Electricity**

Electricity in Macao is at 230V, 50Hz. The power plugs used in Macao are of the three-pin, square-shaped or round-shaped type. It is suggested to check before using an electrical appliance.





### Currency

The Pataca (MOP) is Macao's official currency. Roughly 8 Patacas is equivalent to 1 US Dollar.
