#### ltem 1 -**Opening of the Session**

The Thirty-ninth Session of the Committee on Finance and Administration (CFA) will be opened by the Chairperson.

#### **Adoption of Agenda and Organization of Work** Item 2 -

The Committee may consider the Provisional Agenda and adopt its Agenda for the Session. On the organization of its work, it is to be noted that the schedule of meetings for the work of the Committee will be determined after the usual consultation. The Committee may also constitute the usual informal open-ended working group(s) to assist in the consideration of matters assigned to it.

#### Item 3 -**Admission of Observers**

The Committee may admit those observers as approved by the Council to attend the session as observers.

#### Approved Biennial Administrative Budget for the Years 2024 and 2025 <u>Item 4</u> -[Document CFA(XXXIX)/2]

At its Fifty-ninth Council Session in November 2023, the Council approved the Administrative Budget for the Biennium 2024 and 2025 in accordance with Article 19(4) of the ITTA, 2006 through Council Decision 2(LIX).

There are no revisions to the biennial budget being proposed at this time in accordance with the Financial Rules Rule 3(3).

#### **Review of Contributions to the Administrative Budgets** Item 5 -[Document CFA(XXXIX)/3]

The Committee may examine document CFA(XXXIX)/3 which details Members' contributions to the Administrative Budgets 1986-2024, including assessments, receipts, interests, and arrears.

## <u>Item 8</u> - <u>Auditor's Report for the Financial Year 2023</u> [Document CFA(XXXIX/6, CFA(XXXIX)/CRP-1, CFA(XXXIX)/CRP-2]

The Committee may examine document CFA(XXXIX)/6 (Financial Reports Prepared in Accordance with ITTO Financial Rules and Procedures (Annex 4)) and CFA(XXXIX)/CRP-1 (Management Letter prepared by the Independent Auditors for the ITTO Management) and, if appropriate, recommend to the Council that it accepts the Auditor's Report on the Accounts of the Organization for the financial year 2023. Furthermore, as a condition for ITTO's recent accreditation to the Green Climate Fund, the CFA is requested to provide oversight of ITTO's internal audit activities and assessment of the performance of its independent internal audit function. The Committee may examine document CFA(XXXIX)/CRP-2 (Internal Audit Report) and recommend to the Council that it add this new responsibility to the functions of the CFA.

## Item 9- Election of Chairperson and Vice-Chairperson for 2025

The election of the Chairperson and Vice-Chairperson of the Committee for 2025 will, following past practice, be subject to the usual consultations within the Council and the Committees.

## Item 10- Dates and Venues of the Fortieth and Forty-first Sessions
