SHORTLIST OF COMPLETED PROJECTS RELEVANT FOR EX-POST EVALUATION IN THE FIELD OF REFORESTATION AND FOREST MANAGEMENT

1. INTRODUCTION

The Committee may recall that the ex-post evaluation of 10 completed projects, implemented in Africa under SAP 2013-2021, was carried out for the production of a policy brief, titled "*Lessons for working well together in African forests Policy Brief*". which was distributed at the 8th meeting of the Tokyo International Conference on African Development (TICAD-8), in 2022. -

In 2023, the ex-post evaluation of 10 completed projects and mid-term evaluation of 4 ongoing projects was carried out by the United Nations University (UNU), for the preparation of the UNU-ITTO Technical Report. The aim was to analyze selected 14 projects in Africa, Asia and the Pacific and Latin America and the Caribbean to identify common challenges and lessons learned, including on engaging stakeholders, empowering women and mainstreaming forest landscape restoration (FLR) principles in government policies. This analysis resulted in a policy brief titled: - "Advancing Forest Landscape Restoration in the Tropics: "Experiences and Lessons for Socio-Ecological Resilience and Empowerment of Women in ITTO Projects".

In 2024, Forest Fire was the - thematic group for ex-post evaluations. - Two projects were - evaluated in Indonesia and Peru for the production of a technical report on the thematic assessment of ITTO work on forest fires, to be published in 2025.
