ITTO FELLOWSHIP PROGRAMME 2023 & 2024 (FREEZAILAH FELLOWSHIP FUND)

(Item 13 of the Provisional Agenda)

Introduction

- 1. This document is prepared pursuant to Decision 4(XXVII), which requested the Executive Director to prepare progress reports on the implementation of the ITTO Fellowship Programme for Council's review during its regular Sessions.
- 2. In keeping with this Decision, this document reports on the work related to the implementation of the ITTO Fellowship Programme since the end of the Fifty-ninth Session of the ITTC and outlines measures to be considered at the Sixtieth Session regarding the operation of the Freezailah Fellowship Fund.

Progress in Implementation

3. Advertisement and Dissemination of the ITTO Fellowship Programme

The Secretariat continues to advertise the ITTO Fellowship Programme in the Tropical Update (TFU), the Tropical Timber Market Information, on the ITTO website and our social media platforms, as well as at various events.

4. Status of Fellowship Awards

The Fellowship Programme, which began in 1989, has enabled more than 1,400 young and mid-career people working for governments, universities, research institutions, NGOs and the private sector to pursue their professional development and improve their career prospects.

The Programme mainly supports short-term activities, such as short training courses and internships, and study and demonstration tours. It also provides funds for Manuals/Technical Documents Preparation/Publication/Dissemination, sponsors people to participate in Conference/Seminar/Workshop and provides small grants for post-graduate study.

The Programme provides funds to individuals of ITTO member countries covering a wide range of geographic regions: 40% of the fellowships have been awarded to people from Africa, 30% to people from Asia-Pacific and 30% to people from Latin America/Caribbean. It also focuses on gender balance and encourages capacity development of women foresters. Around 40% of the total number of fellowships have been awarded to female applicants.

Funding

5. The total funds for the Fellowship Programme to date amount to approximately US\$9.8 million. Funding has been provided through the generous voluntary contributions from Japan, U.S.A, the Netherlands, Australia and others including Sweden, U.K., Finland, Bali Partnership Fund Sub-Account (b), the private sector and individual donors. Total available fund for the ITTO Fellowship Programme (2024 cycle) is **US\$ 145,865.38**.

6. Recalling Decision 4(XXVII) which sets a maximum amount of US\$300,000 per year for fellowship awards, until such time that appreciable increases in funding become available, Council may wish to approve additional funds to cover awards, programme support, and other related costs. The Secretariat estimates that to maintain the Programme at the level of 20-30 awards per year, an amount of US\$200,000 would be needed in 2025.

Report of the Fellowship Selection Panel

7. Fellowship selection for 2024 was conducted electronically, and the finalization of the selection of successful applicants for 2024 Cycle was made through email exchanges by the Selection Panel and Secretariat. The Selection Panel of 2024 are as follows:

8. The ITTO Secretariat received a total of 91 applications which were rigorously screened. A total of 19 eligible applications were pre-selected/shortlisted by the Secretariat after a preliminary selection process and recommended to the Fellowship Selection Panel for consideration of fellowship grants. The Selection Panel considered these 19 applications: 7 from Asia Pacific (1 from Cambodia, 2 from India, 2 from Myanmar, 2 from Vietnam); 7 from Latin America: (1 from Brazil, 2 from Colombia, 1 from Mexico and 3 from Peru), and 5 from Africa (3 from Benin and 2 from Togo).

Of the 19 shortlisted applicants, 11 are female and 8 are male; 12 were in the field of Reforestation and Forest Management (RFM), 6 were in the field of Forestry Industry (FI) and 1 was in the field of Economics, Statistics and Markets (ESM).

When reviewing these 19 applications, the Panel used the following selection criteria:

- i) Consistency of the proposed activities with the ITTO Fellowship Programme's objective and priority areas:
- ii) Qualifications of the applicants to undertake the proposed fellowship activities;
- iii) Applications and benefits of the skills and knowledge to be acquired or advanced under the fellowship activities; and
- iv) Reasonableness of costs in relation to the proposed activities.

The Panel took into account the geographic and gender balance, and also took into consideration the ITTO priority areas set in the ITTO Strategic Action Plan in the selection process. The concluded selection result is: 15 applications are fully supported and recommended by panel members for fellowship grants, and 4 applications are recommended for ITTO fellowship grants subject to budget modification/reduction.

The Panel recommends to Council to approve awarding the 19 fellowships with a total budget of US\$131,382.76. The recommended applicants are listed in the Appendix to this report.

- 9. Due to the limited time available during the Council Session, all consultations with the Fellowship Panel Members were conducted successfully through e-mail exchanges/virtually before the Council Session. The final report will be presented to the Council by the ITTC60 Vice-Chairperson, Mr. Carlos Espinosa Peña (Panama), who will provide a short brief on the selection of awardees recommended by the Panel Members.
- 10. The 2025 Fellowship Selection Panel is scheduled to be appointed either during the ITTC60 or before the summer in 2025.
