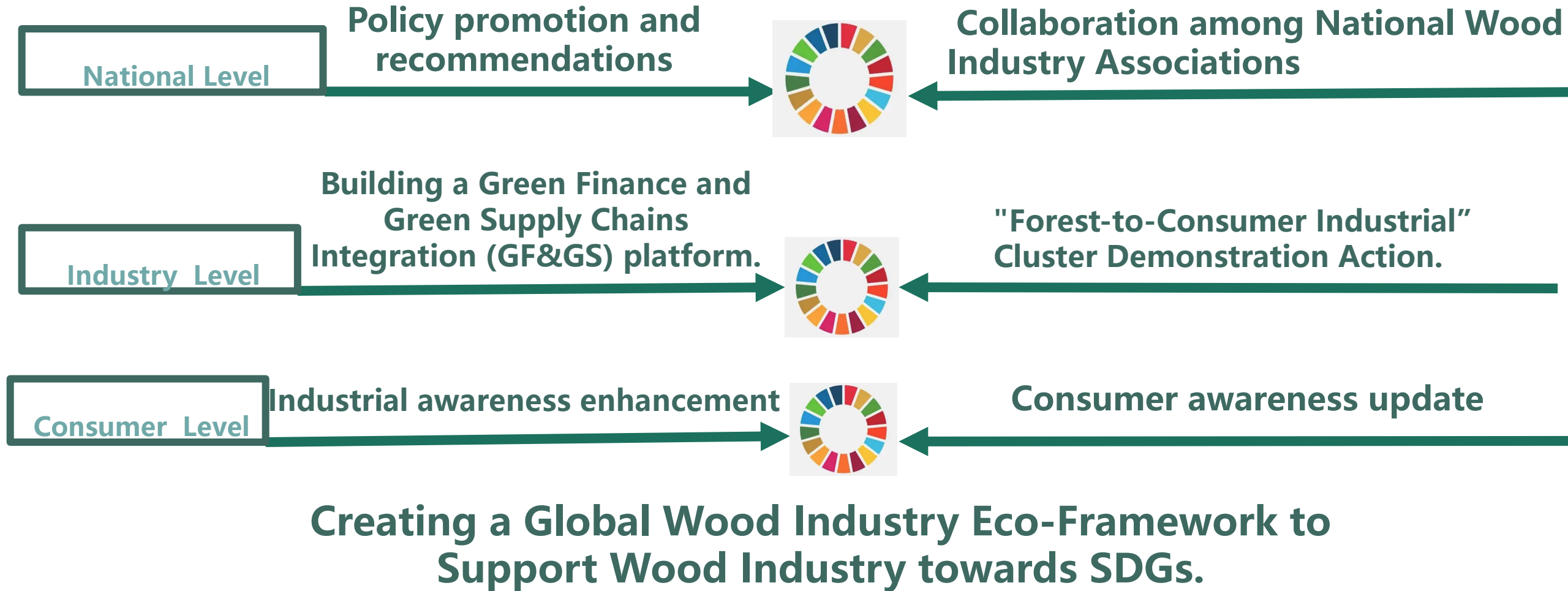

New enterprises and industrial clusters have joined the initiative to build legal and sustainable supply chains.



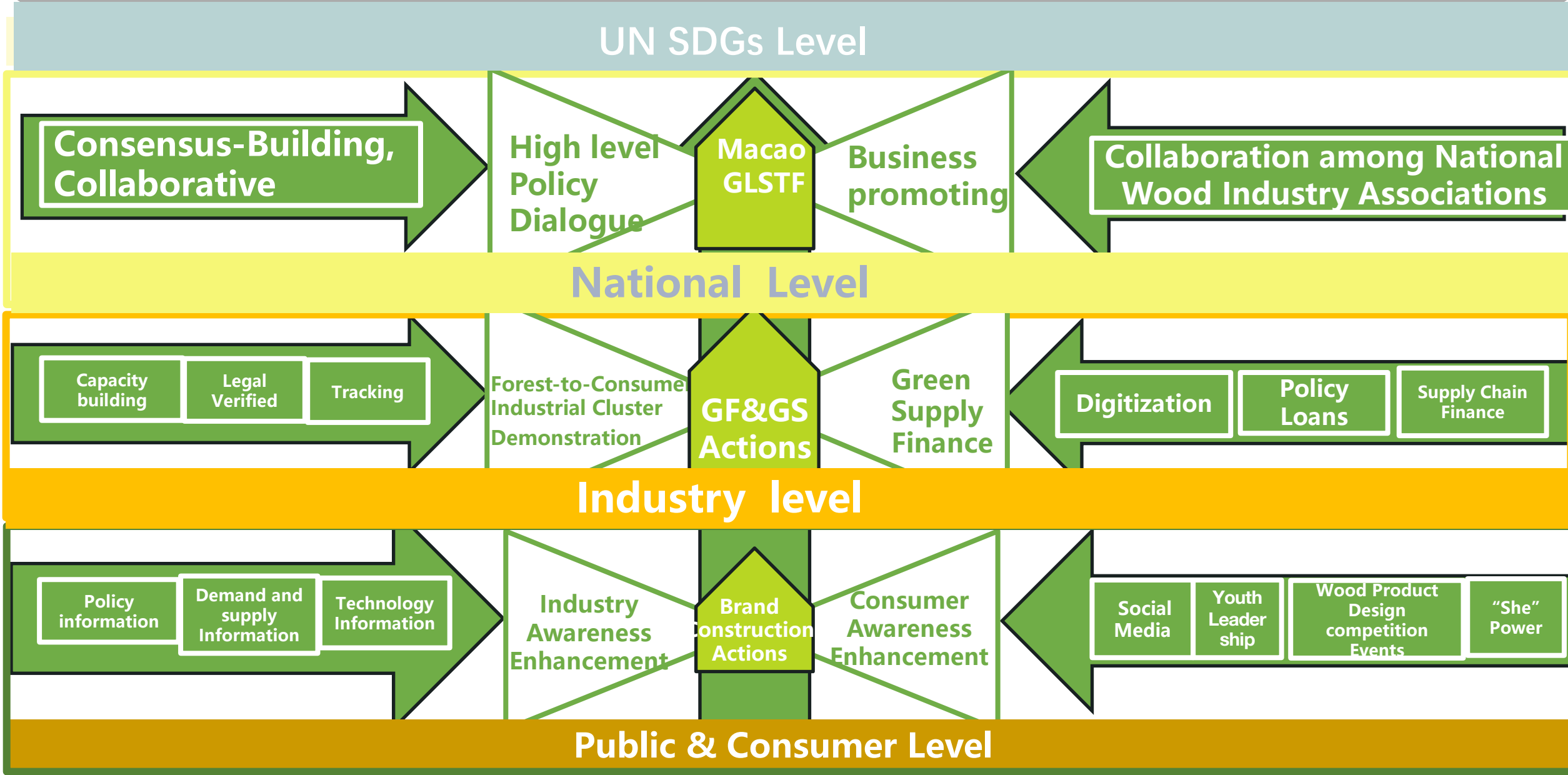

The Monthly GTI Report is based on the survey of the operational conditions of timber sector enterprises in ten pilot countries, reflecting the trends in timber market sentiment in these countries.

Upgrading the Platform of Blockchain-based Timber Traceability System and Conducting Application Tests in Practical Operation Scenarios of Legal and Sustainable Timber Traceability

This activity aims to improve the security of the Blockchain-based Timber Traceability System (BTTS), update the platform, and involve more stakeholders in testing it in real business situations. It addresses technical, safety, and cost issues to boost efficiency in timber supply chains, cut transaction costs, and advance the digital and smart development of the global timber industry.

Action Framework for Promoting Legal & Sustainable Timber Supply Chains

The Action Framework sets out eight action areas—(1) partnership networking; (2) information-sharing; (3) market access facilitation; (4) certification and traceability innovation; (5) innovative technologies and technology transfer; (6) ways and means for sustainable finance and investment; (7) industrial clusters and parks development; and (8) capacity building and training.

The Full Operation of Global Timber Index (GTI) Platform

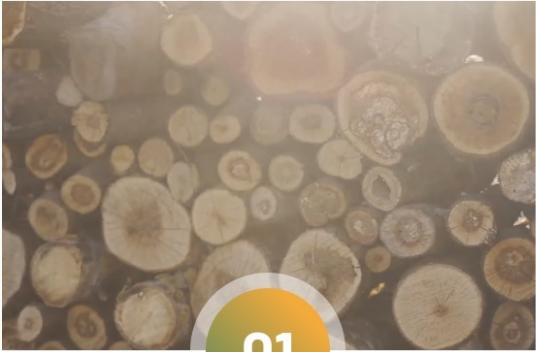
10 pilot countries, 260 participating enterprises

Completed Test of Simulation Platform for Blockchain-based Timber Traceability System (SP-BTTS)

The project has successfully built an IT traceability platform that adapts to real-world business scenarios and international standards.

Sustainable Timber Resources, Markets and Trade

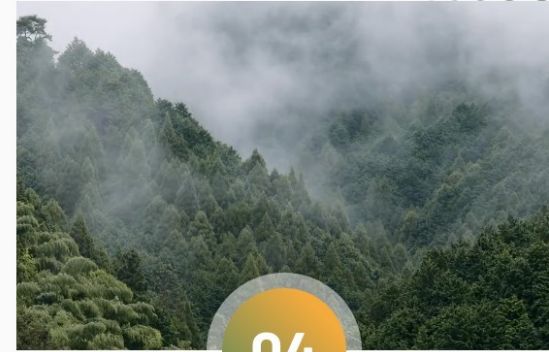

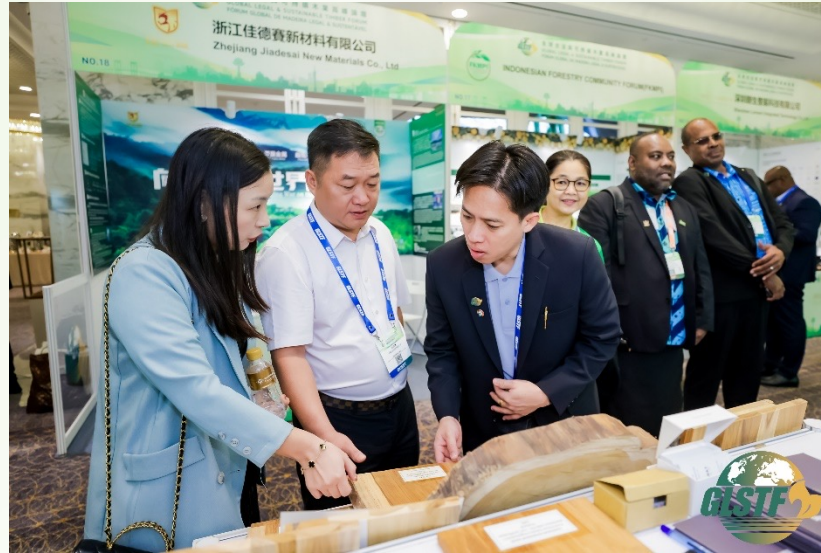
