







8(LVII) Timeline and ToR for Review of PA





Engagement with the Central African Forest Initiative (CAFI) on potential projects.





NEXT STEPS

Council to take a Decision on the future of the pilot Programmatic Approach and four Programme Lines, to consider whether:

- To terminate the pilot phase and continue with the Programmatic Approach & 4 1. Programme Lines, with another review to be conducted in 3 years time (ITTC64) 2027);
- To continue to maintain the Regular Project Cycle (RPC) and run the RPC and the 2. Concept Note approach in parallel; and
- 3. If the RPC is maintained, to keep 2 cycles per year of the RPC OR reduce to 1 cycle per year.
