Article 27/5. If a member has not furnished, for two consecutive years, the statistics and information required under paragraph 3 and has not sought the assistance of the Executive Director, the Executive Director shall initially request an explanation from that member within a specified time. In the event that no satisfactory explanation is forthcoming, the Council shall take such action as it deems appropriate.



JQ 2024 Data Quality

- ❖ 38 countries submitted consistent data on production of wood products
- 40 countries submitted data on trade of primary wood products
- 38 countries submitted data on trade of secondary wood products
- Only 14 countries provided information on production and trade of primary wood products for the year 2024 (sheet ITTO1)
- Only 20 countries provided trade on tropical species (sheet ITTO2)
- Only 11 countries provided insights on their forestry sector (sheet ITTO3)
- ❖ 31 countries were on time (30-Sept-2024)



Database developments

- Updated once a year (next release -> Aug. 2025)
- Statistical training workshop in Mexico, March 2024 (43 forest specialists, technicians, statisticians and academics of five Mesoamerican countries—Costa Rica, Guatemala, Honduras, Mexico and Panama)
- Next statistical training workshop in in Peru, Feb. 2025.
 13 South America countries to be invited
- Long-term review of tropical wood products consumption and trade was published in 2024 (Technical Series 52)
- Conversion factors study for tropical veneer and plywood will be published in Jan. 2025
- □ ITTO plans to fund a study with CIFOR on DRC domestic consumption of timber
- Biennial Review 2023-2024 to be published in mid-2025








Production of tropical logs by region, 2015-2024




MAJOR TRADE FLOWS 2023: TROPICAL LOGS






Major exporters of tropical logs, 2015-2024





Major importers of tropical logs, 2015-2024






West Africa Log Export Price Index





Production of tropical sawnwood, by major ITTO producer country and China, 2015-2024






Tropical sawnwood exports, major tropical countries, 2015-2024






Tropical sawnwood imports, major ITTO countries 2015-2024






Production of tropical plywood, by major country, 2015-2024






Major exporters of tropical plywood, 2015-2024






Major importers of tropical plywood, 2015-2024






World imports of secondary processed wood products, 2015-2024

SPWP imports, by major ITTO importer, 2015-2024






SPWP exports, by major ITTO producer, 2015-2024


