1. PD 933/23 Rev.2 (M) Promotion of Sustainable Teakwood Use in Domestic Markets of India

At the Fifty-ninth Session of the International Tropical Timber Council and Associated Sessions of the Committees (ITTC), held in Pattaya, Thailand, from 13 to 17 November 2023, the Government of Japan expressed interest in funding the project PD 933/23 Rev.1 (M). Consequentially, the Government of Japan requested the revision of this proposal to include the extended component of sustainable wood use. The proposal was revised and resubmitted by the Executing Agency taking into account comments from the Government of Japan. This proposal was placed under the time-bound no objection procedure that was completed on 9 February 2024.

The project's development objective is centered on enhancing sustainable domestic wood consumption of teak in India. Though research and development has produced important results in recent years in all aspects of teak wood production and markets, there exist serious gaps in knowledge management and dissemination to the stakeholders, as well as professional networking among the stakeholders. The specific objective is to promote the sustainable use of teak wood and wood products within the country, by improving policies related to wood certification, building the capacity of stakeholders, and optimizing timber supply chains. This initiative aims to create a more resilient and self-sustaining wood industry in the country while contributing to broader environmental and economic sustainability goals.

Based on the progress report submitted in August 2025, the project has made some progress as elaborated the table below.

Several key outputs have been successfully achieved in line with the project objectives. Comprehensive desk studies and surveys on domestic wood markets are in progress in selected Indian states. A stakeholder consultation meeting had been successfully organized at the Kandla Timber Association Headquarters, Gandhidham, Gujarat, India to gather field-level insights.

Countries such as Thailand, Vietnam, and Cambodia have been identified and invited to participate in the 5th World Teak Conference for knowledge sharing on good practices. Pre- conference promotions have been conducted to engage stakeholders and raise awareness. Additionally, a dedicated conference website (<u>www.worldteakconference2025.com</u>) has been developed, serving as a central hub for information dissemination, registration, and event updates.

At the Fifty-ninth Session of the International Tropical Timber Council and Associated Sessions of the Committees (ITTC), held in Pattaya, Thailand, from 13 to 17 November 2023, the Government of Japan expressed interest in funding the project PD 912/20 Rev.2 (I). The proposal was revised and resubmitted by the Executing Agency to be implemented in two phases for a total of 30 months, thus 15 months each for phase I and II respectively. This split was done considering the pledge made at the Council Session. This proposal was placed under the time-bound no objection procedure that was completed on 19 January 2024. The project agreement was signed in July 2024 and the Executing Agency submitted the Inception Report and all other startup documentation to the ITTO Secretariat in August 2024, after which the first installment of funds was disbursed on 14 August, 2024 marking the official commencement of project implementation followed by the second disbursement made on 11 July, 2025.

The mainstay of the projects in terms of its developmental objective is to contribute to the sustainable development of Peru's timber industry by promoting formal, efficient and competitive market oriented forest enterprises, taking advantage of business opportunities articulated with value chains, and marketing products based on the use of timber from legal sources in managed forests in the Amazon Region of Peru for the benefit of Peruvian society and, in particular, the men and women that depend on the forests for their livelihoods. More specifically, the projective will aim at "strengthening the technical and business management of the forest industry that relies on timber species from the Peruvian Amazon Region" as its specific goal.

After twelve (12) months of implementation based on progress report submitted by the Executing Agency in August 2025, the table below summarizes the progress made so far with phase I scheduled to be completed in November 2025. The twelve-month progress report is available at the Secretariat in Spanish only and can be shared if the need arises.

2. PD 935/23 Rev.1 (I) Promoting Sustainable Wood Use for the Domestic Market in Malaysia

In compliance with the new financing architecture (approved by the 56th ITTC under Decision 4(LVI)), a donor has expressed interest in funding this project proposal developed from Concept Note: CN-23025-Malaysia. The proposal was developed by the Executing Agency in collaboration with the ITTO Secretariat and donor, taking into account comments received during the time-bound electronic no objection procedure that was completed on 18 October 2023. The Japan Forestry Agency pledged funding to this project and the project agreement was signed in April 2024. The disbursement of the 1<sup>st</sup> installment of the project budged has been done at end of September 2024.

The project has the following four outputs, namely: 1) Improved policy framework to drive domestic consumption of wood and wood products; 2) Strengthened capacity to produce wood and wood products to meet local market demands & promote local consumption; 3) Assessed the market demands and supply for sustainable wood and its Chain of Custody with higher quality, more diverse products, fulfilling the due diligence requirements and the commitment to ESG requirements, including carbon emission and the use of IR 4.0 and advanced technologies; and 4) Established an integrated system master plan that integrates existing data platforms and systems.

Based on the progress report submitted in August 2025, the project has made the following progress:

#### Output 1: Improved policy framework to drive domestic consumption of wood and wood products

- 1. Reviews of national and international policies and initiatives on sustainable wood use have been conducted and are currently under analysis to inform policy recommendations.
- 2. A consumer-targeted questionnaire is being refined based on the feedback from the executing agency.
- 3. The draft technical report was reviewed and commented on by the executing agency and is under revision.

Output 2: Strengthened capacity to produce wood and wood products to meet local market demands & promote local consumption

1. A public awareness survey was drafted; a social media platform for the SWU project was officially launched on 15 May 2025 as a medium to promote the domestic SWU; awareness campaign has been conducted. A wood workshop safety guidelines and machine demonstration at the UPM Faculty of Forestry and Environment on 20 June 2025.

2. The timber structure demonstration (Glulam White Seraya Timber House) proposal was submitted to the Executing Agency for promotion.; discussions with the owner are ongoing from:

<u>Output 3:</u> Assessed the market demands and supply for sustainable wood and its Chain of Custody with higher quality, more diverse products, fulfilling the due diligence requirements and the commitment to ESG requirements, including carbon emission and the use of IR 4.0 and advanced technologies

- 1. A review of domestic market constraints and competitiveness was initiated and is in progress.
- 2. A stakeholder survey instrument was developed with several improvements made following suggestions and recommendations.

Output 4: Develop an Information Systems Master Plan (ISMP)

3. PD 943/25 (I) Enhancing Legal and Sustainable Supply Chain in the Wood Industry to Stimulate Good Forestry Governance (Indonesia)

In compliance with the new financing architecture (approved by the 56th ITTC under Decision 4(LVI), a donor expressed interest in funding a concept note, which was subsequently developed into a proposal by the Executing Agency in collaboration with the ITTO Secretariat and donor. The project agreement between ITTO and the Ministry of Forestry, Indonesia was signed on 18 April 2025 and the project has been operational since June 2025.

The project focuses on stimulating good forestry governance by enhancing the legal and sustainable supply chain. Therefore, the proposed project aims to reduce pressure on the forest area supported by good forest and wood industry governance. Finally, stimulating the supporting environment to implement legal and sustainable supply chains and increasing the capacity of the wood industry in the domestic and global markets can prevent over-exploitation and become an enabling condition for better supervision of sustainable forest management and development of the wood industry. By enhancement of the wood

industry performance through the implementation of this proposed project, sustainable forest management and a legal and sustainable supply chain will promote forestry governance, law enforcement, and traceability.

The project's specific objective is to reduce pressure on the North Sumatra Forest area due to illegal activity by stimulating good forest governance through enhanced legal and sustainable supply chains in wood industries. It can be achieved by implementing two outputs: 1) Stimulated implementation of legal and sustainable supply chains of the wood industry to support forest governance; and 2) Increased capacity of the wood industry in the domestic and global markets that cover activities. The outputs will be delivered by fully implementing four planned project activities consisting of: 1) Conduct the study of the legal and sustainable supply chain of the wood industry (Activity 1.1); 2) Develop an integrated platform for the legal and sustainable supply chain of the wood industry (Activity 1.2); 3). Increase the capacity of SME wood industries in domestic and global markets; and 4) disseminate the progress of the legal and sustainable supply chain of the wood industry.

Based on the progress report submitted in August 2025, the project has made some progress. During the period of April – June 2025, the Executing Agency has conducted a preparation for administrative matters that included grant registration to the Ministry of Finance. The implementation of the project started on 1 July 2025. The project's activities 1.1, 1.2, and 2.1 were initiated in August 2025.

The project implementation commenced only recently and will focus on main activities including the following: (i) Conduct a diagnostic assessment of timber availability for the industry; (ii) Facilitate access to

the use of timber products; and (iii) Propose investment programs with a wide range of incentives, developing marketing strategies and training programs aimed at timber industry technicians.

The development objective is to: Establish effective mechanisms for sustainable harvesting, processing and marketing of timber products The specific objective of the project is to: Strengthen the sustainable management and valuation of timber resources to ensure their long-term availability and the ecosystem services they provide with following outputs: Output (i) Diagnostic assessment of timber availability for the industry; output (ii) Facilitating access to the use of timber products; output (iii); Create the appropriate environment for investment in timber processing.
