#### PREFACE

With the support of International Tropical Timber Organization (ITTO), Bamboo Plantation Techniques and Natural Bamboo Forest Management Training Course, Training No. (5) was organized by Project PD 146/02 Rev.1 (I); Promoting Sustainable Utilization of Bamboo through Community Participation in Sustainable Forest Management. Central Forestry Development Training Center (CFDTC) of the Forest Department, Ministry of Forestry supported the training.

The objectives of the training course were to provide knowledge on bamboo forest management, establishment of community forestry, bamboo products processing, extension and marketing of bamboo products, bamboo propagation and bamboo plantation establishment.

The training course was conducted at the Central Forestry Development Training Center (CFDTC) Hmawbi, Yangon Division from 20<sup>th</sup> to 25<sup>th</sup> February 2006. Altogether 22 trainees from the Forest Department and 5 from Metta Development Foundation were recruited.

The training course committee was established on 8th of July, 2004 and chairman and cochairman were U Saw Eh Dah, Coordinator of the project PD 146/02 Rev.1 (I) and U Htun Paw Oo, National project director of the ITTO Bamboo Project respectively. Members of the committee were U Myint Aung, Principle of CFDTC, Dr. San Win and Daw Khin May Lwin, Deputy Project Managers of the project and the secretary of the committee was U Kyaw Win, Deputy Manager of the Project. Other project staffs included for facilitating the training were U Tint Khaing of the Forest Research Institute (Yezin) and U Min Thu of Myanma Timber Enterprise.

The opening ceremony was presided by U Htun Paw Oo, Director of the Forest Research Institute, Forest Department, Ministry of Forestry.

All the 27 trainees passed the evaluation standard after 5 days of intensive training. The criteria for the evaluation included standard test table, the interest and proposed bamboo forest management plan.

#### **Training Procedure**

#### Curriculum

The training course consisted of two parts: lectures and field trips. Since the duration of the training course was short, the lectures provided the basic knowledge on each subjects. Practical training was also given. At the final stage of the training course, field trip was arranged in order to provide the trainees practical experience on bamboo plantation establishment and silvilculture system of natural bamboo forest management.

The contents of training course included Bamboo Forest Management, and Establishment of Community Forest, Bamboo Products Processing, Bamboo Propagation and Plantation Establishment, and Extension and Marketing of Bamboo Products.

## Bamboo Forest Management and Establishment of Community Forestry

The curriculum places its emphasis on management and silvicultural practice of bamboo forest management and ways and means for establishment of community forest. The training was conducted by U Mehm Ko Ko Gyi, National Consultant for Forest Management Section.

#### **Bamboo Products Processing**

The curriculum aims to offer knowledge on the processing techniques of ordinary and value-added bamboo products. U Sein Thet, National Consultant for Bamboo Products Processing Section and Daw Khin May Lwin Deputy Project Manager of Bamboo Products Processing Section conducted the training.

#### **Bamboo Products Extension and Marketing**

The curriculum focuses on the role of bamboo products in domestic and international market, and extension on the awareness of the utilization of bamboo products in Myanmar. Deputy Project Manager of Bamboo Products Extension and Marketing Section, U Kyaw Win gave the lecture.

#### Bamboo propagation and plantation


U Myint Aung, Principal of Central Forestry Development Training Centre (CFTDC), gave a closing speech and presented the Certificate of Achievement to all trainees.

### **Summery of the Training Course**


#### Data on trainees

The total number of trainees was 31. Among them, 22 trainees (81 percent) were from the Forest Department (FD) and 5 trainees (19 percent) were from the Metta Foundation. All the trainees were male by gender. The trainees were from all states and divisions except Tanintharyi Division and Rakhine State.

#### Suggestions

It is significant that Bamboo Plantation Techniques and Natural Bamboo Forest Management Training Course, Training No (5) recruited trainees from almost all states and divisions in Myanmar. The trainees were from the Forest Department and the Metta Development Foundation. It disseminated knowledge and experiences on bamboo forest management, establishment of community forestry, bamboo products processing, bamboo propagation and plantation establishment, and bamboo products marketing. Additionally, the field trip to the bamboo plantation of ITTO project area was a remarkable interconnection between theory and practice. Unlike previous training courses, the Training Course No (5) included the lectures on the situation of bamboo products in international and domestic markets.


It is also expected that the trainees will transfer their knowledge and experiences to their peers for their sustainable benefits. Suggestions were given by the trainees as follows:
