Introduction

Myanmar is well known for her rich biodiversity and has been enlisted as one of the biodiversity hotspots in the world. Forest Department, Ministry of Natural Resources and Environmental Conservation has been trying to conserve and restore the natural habitats of fauna and flora since decades. Up to current, 42 protected areas have been established and they occupied 5.79% of total land area of the country. In 2030, 30% of country total land area has been targeted to demarcate as Protected Areas. In order to accomplish the successful implementation of biodiversity conservation, it is mandatory to raise the awareness and capacity of the stakeholders. To fill this gap, training on "Protected Area System, Biodiversity Conservation and Habitat Management" has been organized by Forest Research Institute, Forest Department, Ministry of Natural Resources and Environmental Conservation with the financial support of FD-ITTO collaborated project entitled "Capacity Building for Strengthening Transboundary Biodiversity Conservation of the Tanintharyi Range in Myanmar (Phase I – Stage I) (PD 723/13 REV.2 (F))".

Objectives

The training was organized with the following objectives;

- 1. To understand the protected area system (PAS) of Myanmar and current activities of biodiversity conservation by means of protected area system,
- 2. To share the nature of biodiversity conservation and practices how to assess the biodiversity,
- 3. To understand the habitat restoration, conservation and sustainable management.

Training period and venue

The training was held for three days from $19^{th} - 21^{st}$ September 2018 at the Popa Mountain Wildlife Sanctuary, Mandalay Region, Myanmar.

Participants of the training

In total, thirty participants (trainees) attended the training. Five participants were Deputy Range Officers working at Forest Department of Tanintharyi Region and twenty-five participants were Forest Rangers working at the different National Parks of Nature and Wildlife Conservation Division, Forest Department. The list and detailed information of the participants were attached in this report as Annex 1.

Logistic Arrangement for the training

The training was funded by the Project entitled "Capacity Building for Strengthening Transboundary Biodiversity Conservation of the Tanintharyi Range in Myanmar (Phase I – Stage I) (PD 723/13 REV.2 (F))" which is being conducted by Forest Research Institute, Forest Department of Myanmar with the financial support of International Tropical Timber Organization (ITTO). Forest Research Institute was the main institution to organize this training while NWCD (Nature and Wildlife Conservation Division of Forest Department and WCS (Wildlife Conservation Society) also jointly organized to the successful accomplishment of the training. Training materials (such as lecture notes) and Training completion certificates were also delivered to the trainees once the training was completed. The sample training certificate (in Myanmar language) was attached as Annex 4.

Review on the training

As the trainers are the professionals currently working on the biodiversity conservation, Protected Area Management and Habitat Restoration in the practical field, the lectures and practical works were compatible with the current trend of those fields. Therefore, it is an effective way of understanding all theories and practices for the trainees to apply those knowledge competently. For the future activities, ITTO Project will apply those experiences to include all relevant professionals and stakeholders from respective organizations for the successful accomplishment of the trainings.

As the trainees were also staffs who are working in Protected Areas and Biodiversity Conservation of Myanmar, they seemed deeply interested during the lectures and actively took part for the discussion sessions. In this context, it is sure that this training can enhance the capacity of staffs in PAs Management, Habitat Restoration and Biodiversity conservation, which is very beneficial for the effective and sustainable management of Protected Areas of Myanmar.

Conclusions

As the Myanmar is rich in Biodiversity, there are many threats to the biodiversity conservation of Myanmar including trans-boundary biodiversity conservation. The main threats include encroachment in the forests for settlement and agricultural activities, illegal hunting and poaching, illegal trade of the wildlife, illegal fishing and weak participation of local people in biodiversity conservation. As Forest Department, Ministry of Natural Resources and Environmental Conservation (MoNREC) has been implementing biodiversity conservation activities throughout the countries as well as along the border areas since long time ago, this training can support those efforts as the part of capacity building and awareness raising for the main stakeholders.
